#### MAIN TASK AND RESPONSIBILITIES:

### Forest-Based Value Chains Advisor:

- Technical coordination of the activities implemented at provincial level (Huaphan, Oudomxay, Xayaburi, Luang Prabang, Khammouane, Vientiane Province, Vientiane Capital), which are amongst others:
  - Facilitation of deforestation-free forest-based value chain partnerships between private sector, government, and villages;
  - Support to producers and small and medium-sized enterprises in identifying, accessing, and promoting (new) markets for products while respecting an inclusive, and biodiversity-friendly trade;
  - Support the planning and implementation of capacity building measures;
  - o Support quality control, monitoring, and evaluation of outputs.
- Advise partner institutions (e.g. Ministry of Agriculture and Forest, Civil Society Organizations, Lao Wood Processing Associations, Lao National Chamber of Commerce and Industry, National University of Laos, and others), identify needs, develop concepts and strategies, and provide technical advice in value chains management and private sector development;
- Manage and facilitate the contact to government partners at capital level;
- Act as value chains and non-timber forest products focal point for government partners at capital level;
- Support the cooperation with the Faculty of Forestry of the National University of Laos in the field of the actualisation of curricula and training material;
- Coordination and implementation of trainings, multi-stakeholder workshops, and other events related to the project activities;
- Coordination with other development projects, EU, and CSOs on joint implementation.

#### Junior Forest-based Value Chains Advisor:

- Facilitation of deforestation-free forest-based value chain partnerships between private sector, government, and villages.
- Support to producers and small and medium-sized enterprises in identifying, accessing, and promoting (new) markets for products while respecting a sustainable, inclusive, and biodiversity-friendly trade.
- Value chain and non-timber forest products focal point for government partners, especially Project Management Units and the district implementation teams.
- Support the planning and implementation of capacity building measures.
- Support quality control, monitoring, and evaluation of outputs at province level.
- Coordinate with other ProFEB components, GIZ projects, EU, and other relevant projects on joint implementation at provincial level.

## **GENERAL QUALIFICATIONS:**

- Oral and written proficiency in English and Lao;
- Working experience with an international organization is an advantage;
- Knowledge of government procedures and institutions, and having an existing network in the field of forestry field are advantage;
- Experiences with private sector development, government procedures and institutions, and having existing networks are assets;

- Prior experience in private sector and village engagement, and in the cooperation with local women's groups are an advantage;
- Good working knowledge of ITC technologies and computer applications (e.g., MS Office);

- B. Sc. Degree, or equivalent, in forestry, environmental science, or related field;
- At least 1 year professional experience in a comparable position;
- Good knowledge of the forestry and wood processing sectors, and value chain assessment and development;
- Experience with field work in harsh and difficult conditions.
