#### Context

The floods that occurred in Bosnia and Herzegovina in May 2014 caused a chain of negative events affecting the business operations of small and medium enterprises: damaged production capacities, loss of stocks resulting in a decrease or discontinuation of production, and eventually cancellation of orders and loss of buyers. As a result, there was a slowdown in development of companies, which had to focus their efforts on damage recovery rather than on market opportunities.

Such circumstances have additionally weakened the competitiveness of SMEs from Bosnia and Herzegovina in the domestic and European market.

In order to strengthen their position in these markets, their products and services have to comply with market requirements, they have to be innovative and to meet and maintain quality standards.

A frequent obstacle for the development of companies is a limited access to necessary information, business expertise and practices as well as business services. The complex business environment is an additional restriction. International reports, such as the Doing Business Index, Global Competitiveness Report or SME Policy Index, indicate that Bosnia and Herzegovina is lagging behind other comparable countries when it comes to simplicity of business company registration or permit issuance process.
