





# Community-Based Local Initiatives Project (CLIP 2)

Community-based local initiatives in Turkey provide multi-sectoral social services for refugees and vulnerable residents of the host communities and strengthen their resilience.

#### **General context**

Türkiye hosts the largest refugee population in the world (around 3,7 million Syrians under temporary protection, 330,000 international protection holders from other nationalities). The situation poses significant challenges to the government in ensuring refugees' access to quality social services as well as guaranteeing their livelihood and protection. Despite the enormous efforts and successes of the government of Türkiye in providing social services to all those in need, poverty, precarious living situations, and psychological stress persist. Access to social support services is particularly limited for vulnerable groups. The situation has deteriorated by the impact of the Covid-19 pandemic. Furthermore, the language barrier is a significant obstacle to social integration and the labour market access. Rising living costs and unemployment also have negative consequences on vulnerable Turkish citizens (i.e., women-led households, persons with disabilities) and restrict social cohesion. Negative coping mechanisms (i.e., domestic or sexual and gender-based violence (SGBV), child labour, and early marriage) may partly be considered as consequences of psychological stress induced by insecure living situations. Civil Society

Organisations (CSOs) that are actively involved in the social and economic integration of refugees for years have the potential to fill those gaps in service delivery. However, particularly in underserved areas, they lack the capacity and expertise to provide needs-based and integrated social services in coordination with relevant state institutions.



#### **Our Approach**

Deutsche Gesellschaft für Internationale Zusammenarbeit GmbH (GIZ) has been supporting the work of NGOs in the refugee response in Türkiye since 2015. CLIP 2 is a multi-donor financed project that community-based local initiatives underserved regions of Türkiye to provide integrated and needs-differentiated services to disadvantaged refugees and vulnerable residents of the Turkish host community. The project builds upon the experiences of the Community Centres and Local Initiatives Project (CLIP 1). It is co-financed by the Germany Federal Ministry for Economic Cooperation and Development (BMZ) and the European Union through its Civil Protection and Humanitarian Aid Operations (ECHO).



#### The CLIP 2 project works in four action fields:

#### 1. Improving protection and specialised support services

GIZ supports local initiatives in improving support services, i.e. legal and social counselling, mental health and psychosocial support (PSS), specialised services for those with specific needs, in particular persons with disabilities and survivors of SGBV. The services are provided for refugees and vulnerable residents of the host community, including single-headed households, unaccompanied minors, LGBTIQA+ persons, seasonal migrants, and child labourers. The target group is empowered to cope with challenges in their living environment, which strengthens their personal resilience.

#### 2. Access to non-formal education

The CLIP 2 implementing partners are strengthened in terms of providing non-formal education such as language courses or courses to improve the target groups' life and work skills. Given the importance of Turkish language skills for access to the labour market and interaction with the local population, and against the backdrop of the precarious economic situation, this provision serves as a basis for improving the personal, economic and social prospects of refugees and members of the host communities.

#### 3. Intercultural understanding and social cohesion

The project supports activities that promote intercultural exchange and social cohesion at the local level such as dialogue events, and cultural and social activities. Through such regular exchange, social tensions can be decreased and mutual understanding between refugees and the host community can be improved.



#### 4. Capacity development and cooperation

The project implements measures at the individual and organisational levels to strengthen technical, management and institutional skills and capacities of local initiatives in Turkey's underserved regions. Moreover, CLIP 2 seeks to reinforce cooperation and coordination mechanisms among NGOs as well as with state partners at all levels. This helps to provide high-quality, integrated, and complementary social services. A peer support network (ADA Türkiye) is established to ensure institutional sustainability.



# Peer Support Network for Sustainability and Localisation

CLIP 2 Peer Support Network (ADA Türkiye) facilitates successful cooperation between experienced NGOs and local initiatives in underserved areas of Turkey to reach out to the most vulnerable refugees and host communities. It fosters the provision of needs-based and high-quality services linked to existing service structures of the state.

The project employs a mentoring perspective with a particular focus on knowledge and experience sharing among project partners on various levels. Large-scale, well-established NGOs that GIZ has worked with within the framework of CLIP 1 receive specialised capacity development support from GIZ to become equipped in supporting and empowering small-scale NGOs in underserved regions. Together with the smaller NGOs, they form a "bundle".


Within the bundle, the capacities of smaller scale organisations are increased in the fields of management, finance, and organisational development as well within thematic areas depending on the organisation's expertise. On the other hand, CLIP 2 also trains and strengthens larger NGOs in their supportive (mentoring) role for a larger impact. Thus, the network creates an enabling environment for mutual learning and exchange. Local authorities are also involved from the start of the projects in each bundle.

ADA Türkiye aims at providing opportunities for civil society organisations of different sizes and capacities to optimise the services they provide and increase their chances to absorb future funding as an entire network.

ADA Türkiye, as an innovative approach, connects implementing partners with varying capacities to each other and promotes peer support, cooperation, and collaboration. This also empowers civil society actors and serves the institutional sustainability of the organisations overall.

#### Intervention area

CLIP 2 implementing partners were selected from provinces with a low level of international donor support, a high proportion of particularly vulnerable refugees (including those from Afghanistan, Iraq, and Iran) and host community residents, and limited social service infrastructure. As a result, CLIP 2 implementing partners operate in the following cities: Adana, Afyon, Ağrı, Aksaray, Amasya, Ankara, Bursa, Elazığ, Erzurum, Gaziantep, Iğdır, Istanbul, Kayseri, Kilis, Kırşehir, Konya, Kütahya, Nevşehir, Niğde, Sakarya, Sivas, Trabzon, Van and Zonguldak.







#### The Benefits

CLIP 2 promotes the provision of multi-sectoral services to strengthen the personal and socio-economic resilience of refugees and vulnerable members of the host community. Resilience refers to the ability and capacity of individuals or communities to develop/use their emotional strength to cope with and recover from shocks and stresses resulting from the impact of forced displacement (e.g. trauma from the past, challenges related to a new environment) as well as current challenges in Türkiye (e.g. economic deterioration, Covid-19) and in this process, deal constructively with requirements of the new living environment (e.g. political, social and cultural rules/norms. educational and employment requirements. demographic changes due to the reception of refugees) without losing their identity and transform their local environment by reforming the existing structures in such a way that stress, change and uncertainty can be managed and integration, participation and cohesion can be ensured in the longer term.

As part of the supported activities, CLIP 2 gives explicit consideration to the provision and facilitation of access to social and protection services. These include advisory and information services, awareness-raising, advocacy and empowerment activities, psychosocial support, and counselling.

In addition, education and skills development activities are supported. Both refugees and Turkish beneficiaries develop skills required to lead a healthy life, successfully organise their everyday life, secure their livelihoods and gain access to the labour market. Combined with measures in protection and social support, this strengthens the self-help capacities of the target groups and paves the way to better social and economic participation.

Social cohesion is a cross-cutting issue. To promote positive relations, the project implements activities at three relationship levels: 1) connecting refugees and vulnerable members of the host communities to state institutions by promoting equal access to social services, 2) providing a safe space for interaction and exchange between refugees and host community members, 3) strengthening the relationship within specific target groups in comparable living situations (e.g. persons with disabilities, women, youth). The social cohesion measures aim to create a safe and supportive environment where the rights and dignity of individuals and groups are respected. This ultimately facilitates participation and positive interactions with others and improves the target groups' self-help capacities and self-esteem as well as their feeling of connectedness to their living environment and access to needs-based social services.

CLIP 2 combines humanitarian approaches with strategies to improve socio-economic prospects and intercultural learning. The project's holistic approach makes it possible to respond to emerging needs, build structures and contribute to social cohesion, making the project an example for the **Humanitarian-Development-Peace** (HDP) Nexus.

Moreover, strengthening cooperation structures between state and non-state actors serves the sustainable integration of the provided services into the Turkish social system. This also secures fulfilment of the target groups' needs in the long term.



# PEER SUPPORT NETWORK FOR SUSTAINABILITY AND LOCALISATION

### **Background**

CLIP 2 is a multi-donor project that supports community-based local initiatives in underserved regions of Türkiye with the aim of providing integrated and needs-differentiated services for disadvantaged refugees and vulnerable members of the host community. The project builds upon the experiences of the Community Centres and Local Initiatives Project (CLIP 1) and is co-financed by the European Union, through its Humanitarian Aid Operations department (ECHO) and the Germany Federal Ministry for Economic Cooperation and Development (BMZ) and implemented by Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH.

The project promotes the provision of multi-sectoral services with the aim of strengthening the personal and socioeconomic resilience of vulnerable individuals, considering the provision and facilitation of access to social and protection services. While doing so, it supports local initiatives and links them to strong and well-established NGOs in the field by improving networking structures, organisational capacities, and coordination mechanisms among CSOs and with state institutions at all levels, through capacity building measures and an NGO mentoring system that is embedded in a larger partner CSO Network.

# **Objectives of the Peer Support Network**

CLIP 2 is a multi-donor project that supports community-based local initiatives in The project has established a peer support network to strengthen capacities of small local organisations, improve their relations with other organisations including public authorities, and create an enabling environment for mutual learning and exchange as well as social cohesion on a local and regional level based on the lessons-learnt from the first phase (CLIP 1) for strengthening civil society actors and improving the resilience of vulnerable communities. The network has the objective to facilitate a successful cooperation between local initiatives and well-established NGOs in underserved areas of Turkey. It will capacitate smaller organisations in their organizational structure as well as their technical expertise for high-quality and integrated service delivery, while also training and strengthening larger NGOs in their supportive ('menting') role for larger impact. It will provide opportunities for civil society organisations of different size and capacities to optimise services they provide and increase their chances to absorb

future funding as an entire network.

The network centres around an approach that takes peer learning and peer exchange as a basis for capacity development, networking and cooperation for the empowerment and sustainability of civil society actors, with special reference to supporting grassroots organisations and local initiatives. It provides a framework for efficient collaboration amongst CLIP 2 partners of different size and capacities and constitutes a sustainable mechanism through which NGOs can work together, get capacitated, establish referral pathways, increase their credibility, and are enabled to receive (national and international) funding in future. The network is planned to be scaled up in future in such a way that it becomes interesting for other actors to buy-in or to take over completely so that it can run independently.

#### Benefits of the Network for its Members

#### For the mentor organisations, the network provides great benefits such as;

- A series of capacity development measures to improve organisational and technical capacities for increased quality in service provision, organisational sustainability, and support to other organisations,
- Increased ability of community outreach via the enabling role of smaller-scale NGOs in underserved regions of Turkey,
- Extended external network with possible referrals to the grassroot organisations in the network, which constitutes an advantage in funding applications,
- Increased ability to design, operate, collaborate, implement projects with local authorities and other organisations,
- Increased outreach to NGOs that are not embedded in the nationwide coordination structures Contribution to the localisation workstream as defined in the Grand Bargain,
- Increasing funding opportunities with a new mentoring role.

#### For the local initiatives, the network provides great benefits such as;

- A series of capacity development measures to improve organisational and technical capacities for increased quality in service provision and organisational sustainability to be provided by GIZ and their mentors,
- Improved and increased cooperation with local authorities with reflections in complementary service provision, strengthened referral pathways, improved recognition as actors of the local response,
- Close (on the job) support of peers in the network (other CSOs) in technical and organizational matters,
- Involvement in local and regional coordination structures with the support/initiatives of their mentors and of the network,
- Greater visibility in the province and region as part of a network Increased funding opportunities and chances for sustainability.







#### We work together to build a strong and resilient future for everyone.

The Civil Society Network for Peer Support and Localisation (ADA Türkiye) was established by Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) initiative in 2021. The network was launched by the Community-Based Local Initiatives Project (CLIP 2) implementation partners to bring together non-governmental organisations that provide holistic and need-based social services to refugees and vulnerable members of the host society in Türkiye and ensure long-term collaboration for dependability.

# We provide needs-based and integrated social services in coordination with relevant public institutions and agencies.

Aimed at strengthening the psychological and socioeconomic resilience of refugees and of the vulnerable members of the host community, ADA Türkiye partner NGOs offer improved and specialised protection, skills development, non-formal education, social cohesion, and capacity development services across Türkiye.

Co-financed by the EU Humanitarian Aid and the German Federal Ministry for Economic Cooperation and Development (BMZ), ADA Türkiye supports its partners under four components:

- 1. improving protection and specialised support services for refugees and vulnerable members of the host community,
- 2. increasing access to non-formal education (NFE),
- 3. promoting social cohesion,
- 4. building institutional and individual capacity as well as interagency cooperation.





#### The mentoring system contributes to localisation efforts.

ADA Türkiye employs a "mentoring" approach, with a focus on knowledge and experience sharing on various levels between implementing partners. Large-scale NGOs are given specialised support for capacity development so they can be prepared to support and empower small-scale local initiatives. Together, they join to form a "bundle." Depending on the expertise of the organisation, the bundle increases the capacity of local initiatives in the areas of management, finance, and organisational development as well as within thematic areas. Moreover, ADA Türkiye also supports and strengthens larger NGOs in their mentoring and supporting roles in order to have a greater impact.

ADA Türkiye also fosters the provision of high-quality needs- and rights-based services linked to the existing service structures of the state. It promotes peer support, collaboration, and cooperation while also linking implementing partners with different capacities to one another as an innovative approach. Additionally, it empowers civil society actors and strengthens the organisations' overall institutional sustainability.

#### We provide a trustworthy partnership for social impact.

Partners of ADA Türkiye target refugees and vulnerable members of the host community. In addition to registered Syrian refugees under temporary protection, the projects' target groups include refugees from Afghanistan, Iraq, and Iran. The projects specifically target disadvantaged and vulnerable groups such as femaleheaded households, single parents, disabled people, victims of gender-based violence, and people in need of psychosocial support.



While promoting services that address the needs of different age groups, as well as women and men, activities to reduce the medium and long-term impact of the COVID-19 pandemic on the target group are also considered. All activities take into account the needs of the host community members and follow the "do no harm" principle.



ADA Türkiye facilitates successful cooperation between experienced NGOs and local initiatives in underserved areas of Turkey to reach out to the most vulnerable refugees and host communities. In this way, it fosters the provision of needs-based and high-quality services linked to existing service structures of the state.



#### About the organisation

RASAS has been offering services to Syrians and refugees in Sultanbeyli district of Istanbul since 2014 and is one of the strongest organisations providing comprehensive and integrated services for refugees. Since its establishment, the centre provides multiple services for refugees and asylum seekers in areas of protection, non-formal education and social cohesion through trainings, awareness raising activities, counselling and MHPSS services as well as shelter support and refugee committees.

#### About the project

The primary goal of the project is to support vulnerable refugees and members of the host community to access existing social services and to provide needs-based protection programmes that improve people's living conditions, well-being and to promote social cohesion.

#### About the organisation

The Association for Solidarity with Refugees provides individual legal and protection counselling and support to refugees/asylum seekers and migrants in the field of asylum-migration. It is an organization specialized in information, awareness building and capacity building activities and advocacy. Multeci-Der has been working on asylum-migration law and refugee protection throughout Türkiye since 2008. During this period, on access to rights and information, social and legal integration for refugees/asylum seekers and migrants from various countries of origin, Multeci-Der has carried out many projects and advocacy activities for capacity building for local communities, awareness-raising, social and legal integration and the fight against discrimination, development of policies and practices that value human rights and human dignity in the field of asylum and migration. As an NGO with specialised knowledge and human rights-based perspective to provide case-specific legal and protection counselling and support in the field of asylum-migration and human rights, Multeci-Der has been carrying out its activities by maintaining its position in the field for many years despite being a small non-governmental organisation.

#### About the project

At the same time, it is aimed to make this relationship more sustainable with social cohesion activities and psychosocial supports.

In addition to the project's primary objectives, the Speech Club activity, which is part of social cohesion activities, aims to improve the participants' Turkish speaking skills. As a result, people's ability to express themselves in Turkish will improve, and they will be able to communicate and meet both their own and their children's needs to the relevant authorities more easily. People who can comfortably speak the language of a foreign country will feel more confident in themselves, and their sense of competence will grow.




