General information

a. Brief information on the project

The improvement of the quality of vocational training and youth employment promotion in South Africa is a key focus area of the German Development Cooperation and the Federal Ministry for Economic Cooperation and Development (BMZ). The "Digital Skills for Jobs and Income" project (DS4JI, 18.2132.1-001.00, Duration: 03/2020 - 03/2024), commissioned to GIZ by BMZ has four main objectives which aim to increase the employment prospects of young people in various sectors through a combination of the following:

I. Access to qualitatively improved and demand-oriented training through integration of digital competences and methods into the training courses of the formal TVET (Technical and Vocational Education and Training) system, specifically at selected TVET colleges with a focus on young people, especially girls and women (Output 1),

II. Demand-oriented further training through financial and technical support of the respective service providers which will lead to an expansion of further training and networking measures and thus enable a larger number of young people to improve their employment prospects about dependent or self-employed employment (Output 2),

III. Improved recruitment policies of companies through the introduction and implementation of new, gender-sensitive approaches to identifying applicants with the digital skills demanded by the company (Output 3),

IV. Increased networking and cooperation of initiatives and actors and the exchange of learning experiences in the transformative process of digitization of the South African economy (Output 4).

At a higher level, improved employment prospects contribute to greater participation in political and economic life and thus also contribute to reducing poverty and social inequality. The project is partly funded by through the #eSkills4Girls initiative.

b. Context

The projects of GIZ's Skills and Employment Cluster are part of the National Pathway Management Network (NPMN) which was established as a central component of the Presidential Youth Employment Intervention (PYEI). The NPMN is a 'network of networks', connecting all existing networks serving unemployed young people. The NPMN creates and aggregates learning and earning opportunities and creates a single entry point for unemployed youth to view and access opportunities in the economy, as well as a range of support services.

The NPMN is organized in various Sub-Committees that address barriers young people face and provide them with active support to enable pathways into the labour market. Against this background, the Sub-Committee on E-Learning was formed, that addresses following problem:

There is an abundance of e-learning platforms, courses and providers nationally and globally that can provide cost-effective and accessible re- and upskilling opportunities to youth that are neither in employment, education and training. However, access, costs, accreditation and certification vary widely. A lack of information and overview provide a barrier for youth to tab into these existing e-learning resources and opportunities.

The sub-committee identified the following key objectives to be addressed:

- Identify existing e-learning resources and opportunities.
- •Establish a database/ repository of e-learning resources and opportunities that is accessible to young people in South Africa. This database should include valuable information about access, costs, certification and accreditation requirements.
- Identify opportunities for organizations in the National Pathway Management Network to make e-learning resources and opportunities accessible for youth or opportunities to upscale existing solutions. This includes identifying gaps in implementing e-learning solutions, establishing this sub-committee as a forum for shared learnings on this topic, and formulating recommendations for organizations.
- Establish a structure for maintaining and updating the database.
- c. GIZ shall hire the contractor for the anticipated contract term, from .12.2023 to 30.01.2024.
- d. The contractor shall provide the following service:

- Contribute to exisiting information gathering and complement the Sub-Committee's research on exisiting e-learning resources and opportunities in South Africa.
- Establish a database/ repository of e-learning resources and opportunities. This database should include valuable information about access, costs, certification and accreditation requirements. The database should have search and filtering functionalities to assist youth with finding offers.
- Assist Sub-Committee to publish database/ repository in the right channels.
- Develop promotional material (social media posts, news articles etc.) to spread published database widely.

Sustainability aspects for travel

GIZ would like to reduce greenhouse gas emissions (CO_2 emissions) caused by travel. When preparing your tender, please incorporate options for reducing emissions, such as selecting the lowest-emission booking class (economy) and using means of transport, airlines and flight routes with a higher CO_2 efficiency. For short distances, travel by train (second class) or emobility should be the preferred option.

If they cannot be avoided, CO_2 emissions caused by air travel should be offset. GIZ specifies a budget for this, through which the carbon offsets can be settled against evidence.

- Our General Terms of Conditions (attached) shall not be changed/amended should you be the winner of this tender. These General Terms and Conditions will form part of the contract should you be awarded this contract.
