# I. General information

#### 1. Brief information on the project

The German Federal Ministry for Economic Cooperation and Development (BMZ) commissioned the Article 6 Capacity Building project as a component of GIZ NDC Assist II global project. The component started in January 2023 with a duration until December 2025. It aims to support national authorities in Rwanda, South Africa and Peru in taking informed decisions on the implementation of Article 6 activities in their countries, which activities contribute both to NDC achievement and SDG financing. For that aim, the component supports relevant actors in the countries to build strategic guidance, processes, procedures, or practical examples for the implementation of cooperation mechanisms under Article 6 of the Paris Agreement. The processes and procedures may include, among others, long-term policy support on sectoral potential analysis, authorisation procedures, and governance structures relevant for Article 6 implementation as well as the support in the development of policy guidelines for an ambitious use of Article 6. An integral part of the project is to foster exchange and learning formats on the use of Article 6 between the three partner countries and beyond. The above support will lead to an increased readiness of host countries to use Article 6 of the Paris Agreement in line with their NDCs achievement. In addition, the component will work with regional and global platforms (e.g., the NDC Partnership) to promote knowledge sharing on lessons learned in partner countries. An international consultant, Neyen Consultancy, has been contracted to support the global project to deliver on these objectives.

In South Africa, the political partner institutions are the Department for Forestry, Fisheries and the Environment (DFFE) and the Department of Mineral Resources and Energy (DMRE).

#### 2. Context

**Article 6** of the Paris Agreement on market mechanisms provides for parties to voluntarily use Article 6 for the implementation of their NDCs. The use of this article is further intended to contribute **more ambitious climate protection efforts** in line with the Paris Agreement. Emission reduction projects used under Article 6 can and should also contribute to **sustainable development**, thereby strengthening synergies between NDCs and SDGs. Several countries have communicated through their NDCs, their desire to utilise market mechanisms under Article 6 to implement parts of their climate targets. By explicitly referring to Article 6 in its updated NDCS, South Africa sets for itself a mandate for establishment of a domestic process of engagement.

To ensure the operationalisation of Article 6 in South Africa, capacities need to be built in a wide range of stakeholders including Governmental Departments directly related to Article 6, relevant line ministries, relevant civil society organisations (CSOs) and Non-Governmental Organisations (NGOs), as well as the private sector in order to engage in the international market mechanisms. To this end, the Article 6 Capacity Building project, in partnership with DFFE as the focal point for Article 6 under the Paris Agreement and DMRE as the earmarked administrator for



Article 6.4 mechanism in South Africa, seeks to contract a national consultant firm to deliver **trainings on Article 6 in South Africa**, with the support of the international consultant.

3. GIZ shall hire the contractor for the anticipated contract term, from 01 May 2024 to 31 December 2024

#### 4. Tasks to be performed by the contractor

# The contractor is responsible for providing the following services:

- 1. Project Inception
  - Inception workshop to be held at GIZ Offices, Pretoria
  - Inception report to be drafted
- 2. Development of training materials on Article 6
  - Develop/adapt training materials (PPT, Factsheets, Handbook) on Article 6 relevant to the South African context. The training materials must include relevant case studies or examples.
    - Training materials developed by the international consultant may be available for use.
  - Develop/adapt a nationally implementable training-of-trainers guide on how to conduct Article 6 trainings for implementation in an interactive training-of-trainers targeted at Government officials and private sector.
    - A training-of-trainers guide developed by the international consultant may be available for use.
- Deliver Article 6-related trainings
  - Implement seven (7) full-day national in-person trainings in three (3) regions of South Africa on Article 6, in coordination with the international consultant:
    - One (1) basic/introductory training on Article 6 targeted at sector departments to be hosted in Gauteng
    - Three (3) basic/introductory trainings on Article 6 targeted at civil society organisations (CSOs), non-government organisations (NGOs) and the private sector to be hosted in Gauteng, KwaZulu-Natal, and the Western Cape (one per province – regional participation from neighbouring provinces)
    - Three (3) advanced trainings on Article 6 on the Article 6 Framework targeted at sector departments, CSOs, NGOs and the private sector to be hosted in Gauteng, KwaZulu-Natal, and the Western Cape (one per province – regional participation from neighbouring provinces)
  - Provide one (1) report on all seven (7) trainings
- 4. Project closeout
  - Handover developed/adapted training materials and other relevant information for use by the GIZ project team and future Article 6 trainers
  - Project closeout meeting to be held at GIZ Offices, Pretoria
  - Provide project closeout report
- 5. Communication



- The Consultant is to maintain regular contact with the project team and partners, providing regular feedback and progress on the implementation of the contract deliverables.
- The contractor will involve the project team and partners at every stage of the project – from scope of the proposed training materials to the final deliverables (outlines, initial drafts, revised drafts and final approval approved materials).
- The project team, including any project structure set up for purposes of reviewing and commenting on the work, will provide a final approval on the deliverables.

It can be noted that the training to be delivered is not an accredited training programme but aimed at providing information, knowledge and awareness on the workings of article 6 and its related implications.

#### 1.3. Expert 3: Intern

The Climate Cluster, under the GIZ South Africa Office, has a project-based intervention, which aims to enhance capacities within the field of climate change and related topics in South Africa. As a means of implementation, it is required that the appointed service provider takes onboard an additional capacity in the form of an intern, to capacitate and expose them to various tasks during project implementation. The training should range from meeting attendance and participation, data collection, support project management and conducting research activities. The appointment period is always recommended to be linked with the project period in question.

# 2. Quantitative requirements

Per-diem and overnight accommodation allowances are reimbursed as a lump sum up to the maximum amounts permissible under tax law for each country as set out in the country table in the circular from the German Federal Ministry of Finance on travel expense remuneration (download at <a href="https://www.bundesfinanzministerium.de">https://www.bundesfinanzministerium.de</a>).

All travel activities must be agreed in advance with the staff member responsible for the project.

#### Sustainability aspects for travel

GIZ would like to reduce greenhouse gas emissions ( $CO_2$  emissions) caused by travel. When preparing your tender, please incorporate options for reducing emissions, such as selecting the lowest-emission booking class (economy) and using means of transport, airlines and flight routes with a higher  $CO_2$  efficiency.

If they cannot be avoided, CO<sub>2</sub> emissions caused by air travel should be offset. GIZ specifies a budget for this, through which the carbon offsets can be settled against evidence.

The market for carbon credits is made up of a large number of providers, each with different claims as to their climate impact. The <u>Development and Climate Alliance</u> has published a <u>list</u> of standards. GIZ recommends using the standards specified there.

- Show at least two (2) reference projects where training material has been developed/adapted and trainings have been implemented in the field of climate policy and/or carbon markets

# III. Requirements on the format of the tender

The CV submitted for each expert can have a maximum of four pages. The concept should not exceed five pages. If one of the maximum page lengths is exceeded, the content appearing after the cut-off point will not be included in the assessment. External content (e.g. links to websites) will also not be considered.
