From 17 to 19 December 2018, EU and Norwegian fisheries ministers met in Brussels to negotiate fishing quotas for 2019 for 150 fish stocks in the North Sea and the Atlantic. Ministers agreed on catch limits for 59 fish species in the new year - six more than in 2018. To read more about these changes and their consequences see here.



# The Underestimated Role of the Life Below Water

The sustainable development goal (SDG) 14 "Life Below water" considers marine species in the sustainable development of humanity for the first time. This is an important step: The oceans cover over 2/3 of the planet's surface and produce more than half of the atmospheric oxygen. However, besides the critical role the SDG still does not get much attention. One of the major challenges to address the importance of life below water is its complexity, which is still poorly understood. This is why ocean enthusiasts have to understand this complexity and find words to translate it to political leaders and society.



# How to improve the value of the Vietnamese Aquaculture Products

The Aquaculture Roundtable Dialogue (ARD)... "How to Improve the Value of the Vietnamese Aquaculture Products" is co-organized by the Directorate of Fishery (D-FISH), Ministry of Agriculture and Rural Development (MARD) in collaboration with Vietnam Association for Seafood Exporters and Producers (VASEP) and GIZ - Integrated Coastal Management Programme (ICMP). The ARD is an initiative by the MARD Public-Private Partnership for the Fisheries Sector. The annual event is a good opportunity for all stakeholders to discuss and share experience on how to improve the value and competitiveness of aquaculture products, especially shrimp and pangasius. Leaders of D-FISH, VASEP, and Director Generals of Minh Phu Group and Vinh Hoan Corporation, as the two biggest producers & exporters and many other companies participated in the event. They stressed that now is the time to promote the advantages of the Viet Nam's aquaculture industry through transparency of production inputs and improvement of seed and feed quality. This is an important step and a pre-requisite for the sustainable development of the industry. Aquaculture products reached a record \$ 5.6 billion for export value in 2017, of which 71% comes from the Mekong Delta, generating millions of jobs, contributing to the stabilization and socioeconomic development. With high potential but also strong competition is the region climate-smart technology innovation must be properly promoted to improve both environmental and social productivity.

# Understanding floods in the Mekong Delta

Flooding is a way of life along the lower Mekong River in Vietnam. Every year between August and November, monsoon rains fill the rivers. The annual floods carry nutrient-rich silt to farmland around the river and provide the moisture needed to grow vast fields of rice. This is the reason why the Mekong Delta plays an important role in terms of food security— not only for Vietnam but also the world.

But the Mekong Delta is facing existential threats due to climate change. The amount of people exposed to flooding, storm surges and seasonal river floods is estimated to increase as the sea level rises, land-use changes and urbanization in flood-prone areas is growing. Therefore, it is necessary to focus on assessing and mapping flood hazard, risk and vulnerability of the Mekong Delta. Would you like to understand causes and effects of floods? # SNRD Working Group – "Hills to Ocean (H2O)"

H2O working group in SNRD-Asia deals with the topics and issues related to water resources management. Mr. Satya Narayan Ghosh is leading this group as speaker along with co-speaker Mr. Terence Paul to facilitate vibrant platform of knowledge exchange and replication of successful practices. This group represents projects in freshwater, coastal and marine sphere covering diverse issues including river protection and rejuvenation, marine protected area management, coastal zone management, aquaculture, coastal protection planning etc. This group brings together an overwhelming knowledge and problem-solving experiences for the sector to address the crisis at scale and multiply impact.

Rapid urbanization and industrialization have led to increase in uncontrolled anthropogenic activities in many folds, and thus, abysmal water quality of rivers, ocean and ground water etc. Over-used of aquatic lives, over exploitation of rivers and fresh water bodies, discharge of waste, habitat degradation and sea level raising have significantly increased the vulnerability of coastal area. GIZ has developed tools and approaches to address these issues and enhance the cross sectoral and marine resources. Below mentioned projects are part of this Working Group.

The Great Silk Road is a system of caravan routes crossing in ancient and middle age time Eurasian continent from Mediterranean Sea to China and influencing the emergence and development of

trade and cultural ties between people and statehoods located along the way.

The "One Belt, One Road" is a grandiose initiative announced in November 2014, consisting of "Silk Road Economic Belt" which goes from China to Europe via Central Asia, and "21st Century Maritime

Silk Road" (MSR) which goes to the Mediterranean Sea via the South China Sea, the Indian Ocean

and the Arabian Sea.

This Chinese initiative has impacts globally, and including the fisheries and other themes that we are

Aquaculture Trainings for HAPA's

To improve the operation of a local hatcheries at the Inle Lake in Myanmar, a training will be offered to teach operators how to use HAPA's. These are simple net cages, in which small fish can be raised. Survival rates in these HAPA's are much higher, as predators cannot access these and feeding can be performed much more efficiently. Furthermore, it also allows for better health check of fish.

After sewing the HAPA's, the operators will learn how to operate them most efficiently. The trainer will come several times in the next months to help with upcoming difficulties and to check the progress.

# Aquaculture Forum in Myanmar

The Eastern part of Myanmar does not have sufficient aquaculture production to meet its demands. Many households are not eating enough fish and malnutrition is a widespread problem. To address these issues, GIZ has organized the First Shan State Forum for Sustainable Fish Production together with the local university, the department of fisheries and private sector representatives. The goal was to provide a platform for all stakeholders to communicate and develop ideas to sustainably intensify the aquaculture sector. One idea was to provide better education & training



# SWIOCeph accomplishes MSC-preassessment

By bringing together supply and demand, the Southwest Indian Ocean Octopus project aims to incentivise sustainable fishing practices. The collaboration between governments, regional management organisations, supply chain partners, fisheries, and NGOs is the main success factor. The GIZ-fisheries team helped to initiate SWIOCeph together with MSC, Blue Ventures and the African Union Interafrican Bureau for Animal Resources (AU-IBAR). It also supported the MSC pre-assessment of the octopus fishery along the south west coastline of Madagascar, focusing the assessment at a Locally Managed Marine Area (LMMA) level of governance and jurisdiction. Subsequently

SWIOCeph is now using these findings to team up with more partners for a further roll-out along the Mozambique channel.

The Sundarbans Management Project (SMP), Bangladesh, with the support of Wildlife Conservation Society organized a series of interactive 'Fish for Future – Playing by the Rules' fairs using different modelled games. These events aim to disseminate information and increase knowledge among local communities on fisheries laws and rules. Eight two days-long events have been organized at different marketplaces located along the Sundarbans Mangrove Forest. So far, 3,564 community members visited these fairs. Since villagers were enthusiastic and appreciated such an innovative idea of playing games to improve knowledge, more fairs are planned by SMP.

From the 24 th-28th September 2018 the AVCP successfully took part in the Sixth PAFFA conference in Mangochi, Malawi. The conference, whose theme is African Fish and Fisheries: Diversity, Conservation and Sustainable Management, has brought together 400 delegates involved within the sector from Africa.

The conference was opened by Hon. Joseph Mwanamvekha, Minister of Agriculture, Irrigation and

Water Development of Malawi. During the opening session, he launched the AVCP Baseline Survey Report together with Dagmar Krenz, deputy head of development cooperation from the German Embassy. The Report was also presented to the participants.

# Active civil society in dialogues on marine biodiversity

In Mauritania, environmental problems in the marine and coastal environments are increasing almost on the daily. This raises the question of how civil society can engage if there is a lack of information and resources for evidence-based lobbying. For this reason a two-day workshop was organized in Nouakchott, in which we worked with 12 civil society partners to increase their understanding of marine and coastal information and data visualization through GIS. These capabilities should enable them to better position themselves in discussions on marine biodiversity and environmental impact, including in dealing with the government and the private sector. To further promote these dialogues, a multi-stakeholder platform for the protection of marine and coastal biodiversity is currently being prepared, with a first meeting scheduled for early December 2018.

# Competition to Promoto Fish Consumption

in Kismayo, Somalia

The first-ever fish cooking competition held in the southern Somali coastal city of Kismayo attracted more than a dozen participants as part of an awareness campaign to significantly increase local fish consumption.

Participants from the city's five neighbourhoods – Guul-wade, Farjano, Calanley, Fanoole, and Shaqaalaha -tried their hand at cooking fish in the competition held on *24 December 2018*. The contest, organised by Star Media Development Centre (SMDC), was won by **Luul Mohamed Guure** from Kismayo's Alanley neighbourhood. She was awarded a prize consisting of a certificate and a trophy.

The contest was part of an effort by German development agency GIZ to raise awareness about the nutritional values of eating fish. Alanley administrator Osman Farah Bando said participants were a role model for other women in Kismayo.

Before the competition, several short radio dramas in Somali, TV and radio talk-shows, public service announcements and roadshows conducted by SMDC highlighted the nutritional values of fish, focusing on the benefits for returning refugees, internally displaced persons & vulnerable residents of Kismayo. Although Somalia has the longest coastline in Africa, after Madagascar, fish consumption remains low and fish is not part of most people's diet. The awareness campaign, dubbed 'Dish on Fish', was aimed at encouraging families living in and around Kismayo to start including fish in their diets. The campaign was also aimed at raising awareness about the nutritional benefits of eating fish and appropriate methods for preparing and preserving fish among returning refugees, internally displaced persons & vulnerable residents of Kismayo. The campaign caught the attention of the population and even encouraged beneficiaries and participants to change their eating habits.

# "MeerWissen" promotes knowledge-based marine conservation

For African coastal states marine and coastal resources are essential for food security and economic development, but also exposed to increasing threats such as pollution and over-exploitation. But many African partner countries lack up-to-date scientific data for efficient management decisions.

Against this background the BMZ-inititative "MeerWissen – African German Partners for Ocean Knowledge" has been developed and launched in November 2018. The initiative seeks to build bridges between African and German research institutions as well as to promote the dialogue among scientists and political decision-makers to implement effective actions for the conservation of oceans and coasts.

# New BMU IKI Project: Identification, demarcation of protected areas and integrated management of marine and coastal zones especially affected by climate change

Duration: 01/2019 - 06/2023

The project will support the Natural National Park Authority in Colombia, as well as the regional environmental authorities and local communities to establish a participative process focused to expand the existing protected areas. The project also aims to provide the protected status to non-protected areas and elaborate integrated management plans to promote sustainable use of the resources by the local resident population. At the same time, it seeks to integrate the protected areas in the integral planning of the marine space and derive concepts of greater reach uses. In this manner, the ecosystem services provided by the protected areas could be considered in the neighboring regions management plans. Moreover, some concepts regarding Ecosystem-based Adaptation (EbA) will be elaborated in order to reinforce the resilience of the local communities. The project will generate experiences in the scope of integrated management of protected marine and coastal areas, the use of protected areas for the adaptation to climate change and the marine territorial planning/demarcation/zoning tied with protection at the Colombian Caribbean Coast. Those learned lessons will be systematized and disseminated at national and international levels.

# (MAR) region: The MAR-network held their 4th regional meeting in Cozumel from January 29th to 31st.

The network is driven by the urgent need to increase economic revenues for local populations, to protect ecosystems as "lifelines" of tourism, and to assure investments in infrastructure, for sustainable destination development. Members stress the fact that cruise tourism offers enormous economic potential, however, only a few benefit from that industry. The destinations are ambitious to seek talks with the cruise industry as a union so that uncontrolled resource abuse is stopped and sustainable destination development can be achieved. During the meeting, participants developed an organizational structure and strategies for a vital the network. Next steps include the appointment of the network's steering committee, representing equally the private, and public sector as well as civil society from each destination. (read more)

# Benchmarking the seafood industry

Seafood is the single largest globally traded food commodity. With a small number (30) of companies holding the largest share of production and trade, it would be beneficial to benchmark their sustainability development and performance. This is the goal of the Seafood Stewardship Index (SSI), by using the sustainable development goals as criteria in a multi-stakeholder dialogue and research. The methodology is still in a development phase in which

stakeholders were invited for consolidation. The final methodology is expected to be published in April 2019.
