

# CHANGING THE PARADIGM OF THE MUNICIPAL SOLID WASTE MANAGEMENT IN NAUCALPAN, MEXICO

In Mexico, 102,895 tonnes of waste are generated daily, of which 83.93% are collected and 78.54% are disposed of final disposal sites. Only 9.63% of the waste is recycled.

The waste sector contributes to 4.6% of GHG emissions. 28% of these emissions would need to be reduced in order to reach Mexico’s NDCs.

To achieve the reduction of GHG emissions, a proper management of solid waste is essential. This includes the closure of landfills, support for sanitary landfills, the construction of biodigesters construction, operating organizations as well as the development of integrated waste management plans.

## Waste management in Naucalpan

Naucalpan de Juarez is a municipality in the State of Mexico with a population of 872,320 inhabitants.

Currently, in Naucalpan waste is collected and then disposed of in a landfill, not taking advantage of potential energetic use of the waste.

With the proposed project Naucalpan wants to significantly improve the waste management system. Municipal solid waste (MSW) separation and treatment in a mechanical and biological treatment (MBT) facility is envisaged to attain landfill deviation of MSW streams. All recyclable materials will be separated and sent through the existing recycling channels while the organic waste from a green bin collection will be treated at the anaerobic digestion facility.

FELICITY prioritizes the interest of cities and incorporates the perspective of international financiers.



The estimated budget of \$1,140 million MXN or €45 million will finance the following components:

- Infrastructure adaptation works (i.e. ground stabilisation and road reinforcement)
- Mechanical separation facility
- Anaerobic digestion facility
- Post-treatment of digestate to produce a high concentrate certified biofertilizer
- 3 combined heat and power units with 7.9 MW electric and 6.7 MW thermal installed capacity
- Connection to the public electricity network.
- 200,000 green bins for the Naucalpan population

The project can potentially reduce annual CO<sub>2</sub> emissions by 77,000 tonnes. In addition, the municipality will improve its public service delivery for the citizens.
