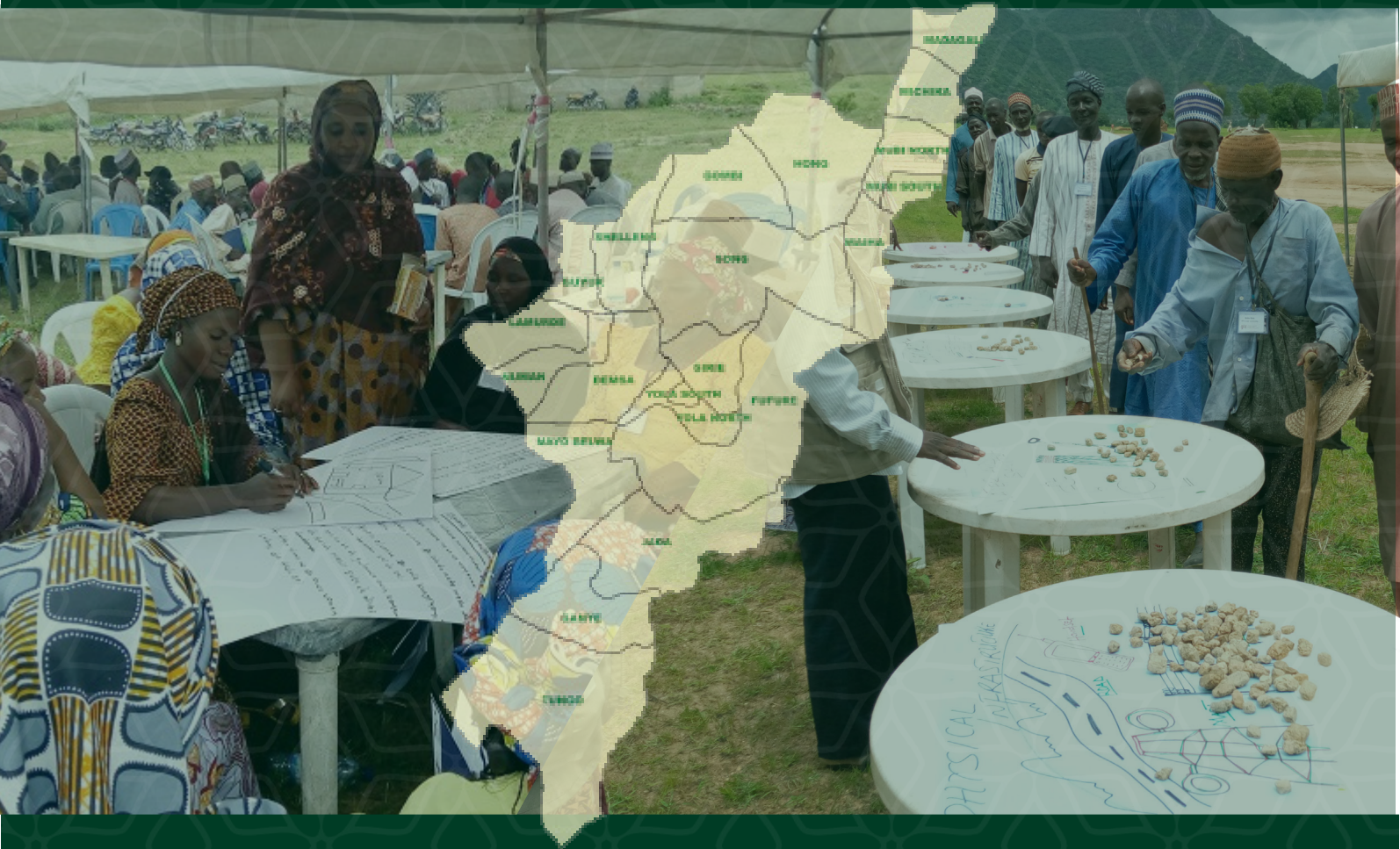

# FOREWORD

In most Nigerian states, there are significant gaps and barriers to effective citizen engagement. As a result, in keeping with the desire for positive change, Adamawa State develops the country's first Citizen Engagement and Participatory Policy as a commitment to open, transparent, and all-inclusive reform processes. In many rural communities across the State citizens lack the formal framework to participate in the decisions that affect their daily lives, and this results in a lack of trust between citizens and local officials.

Crucial to bridging this gap is the use of appropriate strategies to encourage citizens and government officials to interact regularly, increase their knowledge of each other, and develop trust for sustainable development. The lives and hope of citizens for improved life everywhere are shaped by public policies. Consequently, the ongoing strategic public sector reforms are largely dependent on comprehensive social inclusion, citizen engagement and people-oriented social service delivery in a manner that allows for citizens to have equitable access to public goods and quality service. The State has made efforts by engaging local stakeholders through a Town-Hall meeting on the 10th of July 2020 and the 16th of December, 2020 and a Community Engagement of Girei Local Government Area on the 31st of May, 2021. On all occasions, the engagement with citizens of the respective communities was robust, interactive, and revealing. It was participatory, budget context-specific but not inclusive in the perspective of myriads of citizens' needs.

The Citizen Engagement and Participatory Planning Policy is a public policy designed to promote a permanent dialogue between citizens and government that are all-inclusive and within a formal framework that is carefully articulated for the sustainable development of the entire state. Important to mention as well is that this policy is accompanied by an implementation guideline. I, therefore, direct all ministries, Departments, Agencies, Development Partners, Civil Society Organizations, and all interest groups to utilize this policy by aligning priority areas relevant to citizens' demands this will curtail development disparities and governance discontent among citizens.

# PREFACE

The Citizen Engagement and Participatory Planning Policy is a policy document formulated through extensive consultation across a broad spectrum of stakeholders in Adamawa State. The policy seeks to enhance legitimacy and trust in governance through an efficient and effective consultative decision-making process that manages citizens' expectations based on ownership of development processes. It is premised on the need to pursue reforms and strategies that strengthen accountability in service delivery and is a reflection of the government's desire to address long-lasting barriers to development. This policy is centred on Social Sustainability and Inclusion and is in line with World Bank's Social Sustainability and Inclusion Global Practice.

The framework addresses aspects of citizen engagement and participatory planning in the state and is applicable at the state, local government, and ward levels. It specifies entry points, information dissemination channels, and feedback mechanisms, and it is aimed at all Adamawa State communities while ensuring the inclusion of all, including minority groups, vulnerable groups, women, men, youth, CSOs, FBOs, IDPs, and so on.

The policy's goal is to strengthen and sustain grassroots-based inclusive decision-making and governance, as well as to promote equitable local development, by enhancing citizen participation through effective, functional, and mutually accountable linkages between state and local governments, primarily through Community Development Plans (CDPs). The policy is also accompanied by an implementation guideline, which will guide and ensure proper implementation.

The production of this CEPP Policy and Implementation guideline was facilitated by the generous support of GIZ through funding and provision of technical advice as well as Ministries Departments and Agencies (MDAs), Civil Society Organizations (CSOs), Traditional leaders and the International Community. This support is laudable and is highly appreciated.

# INTRODUCTION

---

---

Adamawa State's drive for reform includes but is not limited to the implementation of open government initiatives, fiscal transparency, and citizens' engagement. Efforts in this direction were started by the State Planning Commission through a Town-Hall meeting of Citizens from four Local Government Areas on the 10th of July 2020, 16th of December 2020 and a Community Engagement of Girei Local Government Area held on the 31st of May 2021. On both occasions, the state governments' engagement with stakeholder representatives of the respective communities was robust, interactive, and revealing. It was both participatory and budget context-specific and therefore inclusive in the perspective of myriads of citizens' needs though not sufficient. By frequently engaging citizens, it is believed that they will contribute with innovative solutions to complex development challenges and play a critical role in advocating and helping to make public institutions more transparent, accountable, and effective

# BASIS

The basis for developing this policy is the recognition of the importance of engaging citizens in participatory planning in order to bridge the gap in decision-making processes and bring about sustainable development in communities

# PURPOSE

---

---

In the public service sector, participation and citizen engagement are anchored on the delivery of quality public services consistent with citizen preferences while managing fiscal resources prudently. The general purpose of this policy is to institutionalize and sustain citizens' engagement and participatory planning in Adamawa State by ensuring that the voice and aspirations of the citizens are captured. The policy provides a pathway to commence, galvanize and support constant engagement and feedback mechanism with the citizens of the state including opinion leaders, traditional and religious leaders, civil society organizations, women, youth, persons living with disabilities and other interest groups as community stakeholders

# GOAL AND OBJECTIVES

---

---

The goal of the policy is to deepen and sustain grassroots-based inclusive decision-making and governance and to promote equitable local development by enhancing citizen participation for sustained development in communities of Adamawa state through effective functional and mutual accountable linkages between State and Local Government. The specific objectives are to:

1. increase the direct representation of all citizens in decision-making for sustainable development and gain greater control over their lives and their community,
2. enhance and sustain inclusive citizens' involvement in participatory planning processes

and decision making for their development

3. increase the capacity of communities to develop community development plans (CDPs) in their respective local government areas
4. increase citizen engagement and participatory planning in the community development planning process
5. provide a formal framework upon which the government is committed to integrating Community Development Plans into local and state government budgets
6. enhance and sustain the spirit of social cohesion by consolidating unity.
7. build and consolidate volunteerism, community work and self-reliance based on cultural and other values of collective responsibility, personal worth and productive involvement

## **RATIONALE**

---

---

POLICY is generally a deliberate guideline to guide decisions and achieve rational outcomes. Where there are no policies, things are done haphazardly and achieving the expected outcome is always difficult. Policy is meant to ensure that procedures laid down are followed during implementation. A policy framework is therefore imperative for successful running and operations as well as achieving the desired development in communities and organisations.

Citizen engagement is a form of interaction between the government and its citizens. It can happen at any stage of the development or implementation of government policy and the delivery of public services or be triggered by events in local areas. The main objective of citizen engagement is to provide information exchange, education, support building, supplemental decision making, and representational input. The World Bank in its Strategic Framework for Mainstreaming Citizen Engagement in World Bank Operations indicates that the objective is to mainstream the Group-supported policies, programmes, projects, advisory services, and analytics to improve development results and contribute to building sustainable national systems for citizens engagement with governments and the private sector. The implication of this is to underscore the importance and value of entrenching citizen engagement and a participatory planning process for sustainable community development.

GIZ has implemented a more robust citizen engagement process which is highly participatory through the community development planning process in five local government areas (LGAs) of Adamawa State: Gombi, Hong, Maiha, Mubi North, and Mubi South which has impacted positively on communities in these areas. However, this initiative needs to be institutionalised and sustained across the entire state for development. This can be done through the provision of a robust policy document that serves as a guide for citizen engagement in the planning and implementation of programmes.

Adamawa state does not have a framework for citizen engagement in participatory planning for community development. At best the state engaged citizens through isolated meetings/activities (in the three senatorial zones) to obtain some ideas and opinions about their needs. While the foregoing effort is commendable, there is a need for a more robust and sustained engagement of citizens through a structured instrument to determine



their community development needs. This can be achieved through the provision of a policy framework that will provide an enabling environment in which every citizen, without discrimination, actively participates in the planning and implementation process for community development to feel valued and respected. Furthermore, the policy will enhance the quality of planning by creating processes that are more democratic, equitable and all-inclusive. The poor and vulnerable often have little voice in government decisions, consultations, and dialogue between government actors. Civil Society Organizations (CSOs) that advocate for the poor and vulnerable can give them a stronger voice and influence over government decisions. This will bring about community-oriented projects, a feeling of ownership and sustainability, as well as increased transparency and accountability in government decision making processes.

This policy is meant to achieve a citizen-based sustainable development programme where all stakeholders irrespective of social status, gender, class, education etc. are engaged in determining their development needs at Individual, Community, ward, Local Government and State levels.

## **POLICY FORMULATION PROCESS**

The process used to develop this policy was participatory and consultative initiated by the Adamawa State Planning Commission. This is the commission with the key mandate to promote open and inclusive governance, provide policy advice on development plans to the Governor in all spheres of life including governance, hold periodic meetings with similar bodies that may be set up by the State and Local Governments, strengthen partnership and participation in development matters with stakeholders and, to strengthen governance mechanism for effective and evidence-based policymaking. The need for this Policy aroused from the desire to foster good governance, promote transparency, and increase social justice by involving the poor and excluded, thereby improving public service deliveries and policy projects. It started with the noticeable gap in organizing inclusive Citizens Engagement by the commission and because of the centrality of citizens and participation in governance, other line Ministries, Departments and Agencies were thought crucial. A High-level meeting was organized and attended by top government functionaries such as Honourable Commissioners, Members of the State House of Assembly, Permanent –Secretaries, Executive Chairmen of agencies, Directors of Planning and research of various ministries, Civil Society Organizations, Traditional Leaders and Local Government representatives in Abuja on the 9th -10th December 2021. The goal of such a process was to ensure that the policy is evidence-based and that the views of the government and key stakeholders in governance are reflected. The underlying principle, objectives, goals, and framework of the policy were discussed, and a commitment to the entire policy formulation and implementation process was agreed upon.

Following that, a technical and input collation workshop for the policy was held from the 26th to the 28th of January 2022, with stakeholders in attendance including Permanent-Secretaries and Directors of Planning from key MDAs, Members of the State Citizens Budget Committee, Civil Society Organizations, International Development Partners, and others. The technical and input collation workshop aimed to collect the main technical inputs that would form the core of the policy and implementation guidelines from stakeholders, experts, and practitioners. The draft policy was then subjected to review and validation by the above-mentioned stakeholders in a two-day validation workshop from the 29th to the 30th of March 2022.

## POLICY CONTEXT

---

This policy originated from the need to pursue reforms and strategies that strengthen accountability in service delivery, and it reflects the government's desire to address long-term development barriers, including a greater emphasis on people who have been excluded from economic and social opportunities, as well as increased investment in inclusive growth. The policy is centred on social sustainability and inclusion, and it is consistent with the World Bank's Social Sustainability and Inclusion Global Practice

## SCOPE OF THE POLICY

The policy is aimed at Adamawa state's communities, ensuring the inclusion of all, including minority groups, vulnerable groups, women, men, youth, CSOs, FBOs, IDPs, and so on. The policy's target groups include those who will be affected directly or indirectly

## DEFINITION OF KEY TERMS

---

The need for providing clear and consistent definitions of some terms used for the purpose of the document is essential, according to the literature review and discussion during the workshop on the development of this policy. As a result, the following terms are defined as they are used:

**Citizen:** A native or naturalized member of Nigeria who owes allegiance to Nigeria and is entitled to the protection of the Federal Republic of Nigeria. Citizens can act as individuals or organize themselves into associations and groups such as community-based groups, women's groups, youth groups, indigenous peoples' groups or Civil society organizations (CSOs) and Faith-based Organisations.

**Citizen Engagement:** Any form of interaction between the government of Adamawa State and citizens. It can be two way or multi-dimensional and provides citizens with an opportunity to influence public decisions.

**Participatory Planning:** Government and community efforts to reach a given socio-economic goal by consciously working together to identify problems and charting a course of action to collectively resolve identified issues. It is a planning/governance process in which everyone who has a stake in the community has a voice, either in person or by representation.

**Inclusion:** Provision of equal access to opportunities and resources for people who might otherwise be excluded or marginalized.

**Exclusion:** A situation where some people are denied (marginalised, excluded) equal access to opportunities, resources, and services

**Mainstreaming inclusion:** A conscious effort to include and provide equal access to opportunities and resources for people who might otherwise be excluded or marginalized in all processes.

**Stakeholder:** A person or organization with an interest or concern in governance and policy development, whether directly or indirectly.

**Community:** A social group of people who live in a specific area and share a common government, basic amenities, and cultural and historical heritage.

**Development:** Improvement in the socio-economic well-being of every individual in the community.

**Community Development:** A process in which people come together to make collective decisions and take action on issues that are important to them.

## OWNERSHIP OF THE POLICY

The ownership of this policy rests with the Adamawa State government, but it has been delegated to the Adamawa State Planning Commission, which is responsible for the planning and coordination of the state's budgetary and development programmes. The commission is in charge of the policy's content and accuracy, the coordination of its implementation as well as the review and updating of the content as needed.

## GUIDING PRINCIPLES

The underlying principles and values of this policy are:

**The Sustainable Development Goals (SDGs)** - are designed to end poverty, hunger, AIDS, and discrimination against women and bring about general and sustained development in communities.

**Rights-based Approach** - Citizens have the right to participate in the planning, development, implementation, monitoring and evaluation of this policy, as well as

relevant programmes that concern and affect their development and well-being.

**Participatory and consultative** - All stakeholders including local, state, and federal governments, CSOs, organised private sector and international development partners agree to work together in partnership for the development of communities. The interest of various stakeholders' groups is important in the context of this policy. The clamour and agitations by communities for inclusiveness in determining decisions and implementation of programmes that directly affect them.

The policy provides for equal access to opportunities and resources for people who might otherwise be excluded or marginalized, such as those having physical or mental disabilities or belonging to other minority groups.

**Gender equity and equality** - This policy is also guided by the National Gender Policy document, 2006. All citizens, male and female, have equal rights to participate in the identification and prioritisation of community needs, planning, implementation and monitoring and evaluation programmes that affect them.

**Principles of equity and natural justice** - All citizens have equal rights to involvement and engagement in the planning, implementation and monitoring and evaluation of programmes that affect them in the spirit of justice and fair play and to participate in their own and community's development.

**Cultural sensitivity** - The planning, development, and implementation of programmes in communities under this policy is culturally sensitive and based on local values that support an enabling environment for sustainable development

**Diversity of communities and citizens' needs** - Adamawa state is made up of diverse groups including ethnic, cultural, vulnerable and minorities. This policy considers this diversity and encourages strength in diversity.

This policy also strongly aligns with the Adamawa State Public Finance and Control Law, 2016, the LGA revised law 2018 and even the state and sectoral development plans.

## STRATEGIC FOCUS AREAS

### **Citizen Mobilisation and Sensitisation Responsibility**

The following groups are responsible for mobilisation and sensitisation activities in communities and should be engaged appropriately when the specific needs arise:

- ◆ Traditional Rulers
- ◆ Religious leaders
- ◆ Political leaders
- ◆ Women groups
- ◆ Youth groups
- ◆ CSOs
- ◆ Town announcers

- ◆ Media organizations
- ◆ Professional bodies
- ◆ Private sectors
- ◆ PLWDs
- ◆ Legislators
- ◆ National Orientation Agency (NOA)

## How to carry out Citizen Mobilisation and Sensitisation Responsibility

Strategies to be adopted by the above groups include but are not limited to:

- ◆ Conducting a stakeholder analysis for proper guidance on stakeholders to engage
- ◆ Advocacy visits to the critical stakeholders in the ward
- ◆ Community dialogue using town hall meeting approach in Wards
- ◆ Drama presentation
- ◆ Jingles production and airing in different media houses such as radio, TV in different local dialects
- ◆ House-to-house mobilizations
- ◆ Use of town announcers to create awareness and arouse interest in the policy
- ◆ Radio and TV programmes
- ◆ Billboards with specific messages targeting specific categories of community members
- ◆ Social Media platforms

## Roles and Responsibilities

**Compliance:** A compliance system and structure shall be set up and saddled with the responsibilities of ensuring that the policy is strictly adhered to. It will ensure this policy functions in a legal and ethical manner while meeting its goals. Consequently, it will have five areas of responsibility—**identification, prevention, monitoring and detection, resolution, and advisory**. A compliance system shall identify risks and advises on how to avoid or address them.

The stakeholders responsible for compliance are:

- ◆ Government - Executive, Legislature, MDAs, LGAs
- ◆ Ward Development Support Committees (WDSCs)
- ◆ Civil society organizations (CSOs)
- ◆ Women groups
- ◆ Youths
- ◆ Community Development Associations

- ◆ Religious leaders
- ◆ Traditional rulers

Typically, the responsibilities shall include the following:

Government

- a. coordinating and attending meetings with stakeholders.
- b. coordinating and conducting internal investigations into compliance issues.
- c. lead internal reviews and audits to ensure all LGAs and other stakeholders are complying with procedures of the CDP process for citizen engagement and participatory planning.
- d. lead conducting internal risk assessments and identifying, assessing and managing risks.
- e. ensuring all activities, policies, and documentation are compliant with local, state, and federal government regulations.

### **Ward Development Support Committees (WDSCs)**

- a. reporting to the Local Government Development Coordination Committee (LGDCC) on policy for citizen engagement and participatory planning process on matters of risk, compliance, and legislation
- b. continuous mobilisation and sensitisation of community members
- c. reporting and documenting activities
- d. ensuring record management systems are kept up to date.

### **Civil society organizations (CSOs)**

- a. monitor activities, policies, documentation, and reports to ensure compliance with local, state and federal government regulations
- b. provide capacity building support to communities in compliance with the implementation of the policy

### **All other interest groups**

- a. monitor compliance with policy and report any challenges or deviation

### **Review**

- ◆ When necessary, the review process of this policy will engage all relevant stakeholders including:
- ◆ Government (Adamawa State Planning Commission, Fiscal Responsibility Commission and State Bureau of Statistics)
- ◆ Ward Development Support Committees (WDSCs)
- ◆ Civil society organizations (CSOs)
- ◆ All community members - representatives of all categories including minorities,

vulnerable groups, men, women, professional groups, IDPs, PLWDs, etc.

## Stakeholders

To ensure inclusiveness, the categories of citizens targeted in this policy are:

- ◆ Traditional rulers
- ◆ Religious leaders
- ◆ Political Rulers
- ◆ Vulnerable groups (Minority groups, People living with disabilities, IDPs, widows, retirees and the aged)
- ◆ Women groups
- ◆ Youth groups
- ◆ Professional groups
- ◆ Civil Society Organizations (CSOs) including Community vigilante groups
- ◆ Development partners
- ◆ At-risk Populations e.g. sex workers, drug users

## STRATEGIES FOR ENGAGEMENT

Citizens should be engaged and mobilised using the following strategies:

At the Local Government Level

- ◆ Advocacy to the following groups to obtain permission and buy-in for programmes:
  - ✓ Local Government Councils: Chairman and Council.
  - ✓ Wards: Traditional Rulers and councillors
  - ✓ Community key Stakeholders:

**To get the necessary permission to commence with programmes the following steps shall be undertaken:**

- ◆ Proper stakeholder analysis
- ◆ Meeting with key stakeholders.
- ◆ Sensitization and Advocacy of key stakeholders.
- ◆ The mobilization is done by the key stakeholders or actors of the host community.

**At ward level**

- ◆ Use of advocacy and lobbying as a strategy for sensitization and buy-in of key stakeholders.
- ◆ Inclusion of marginalized groups.

To ensure the inclusion of marginalised groups deliberate actions should be taken to identify and involve/engage such groups:

- ✓ All groups should have separate meetings to enable full and intentional participation.
- ✓ categorisation of groups by Gender and Age.
- ✓ Participation of Persons Living with Disability should be emphasized.
- ✓ Perceived marginalized members should be invited.
- ◆ The casting of votes should be adopted by community or group members to determine and take a decision on the priority needs of the host community.
- ◆ The most voted or identified issue should be considered a priority project.
- ◆ Strategy for citizen input collation of plans, development plans or reports shall include the use of Focus group discussions (FGDs), ranking and other participatory methods.

## **TECHNICAL FOCUS AND CONTENT OF ENGAGEMENT SESSIONS**

### **Issues to be discussed**

- ◆ The engagement of citizens in budget planning and other MDAs activities that affect a particular community.
- ◆ Priority needs of communities
- ◆ Ownership of projects.
- ◆ Community participation - inclusiveness

### **What should inform a project identification:**

- ◆ Needs assessment.
- ◆ Priority needs of community members.
- ◆ The number of votes on a particular issue or problem.

### **Facilitators for the sessions:**

- ◆ Training of Trainers (TOT) trainings to be conducted for literate community members on Citizen Budget engagement and subsequent step-down trainings for community enumerators supported by the staff of the relevant MDAs.



# POLICY IMPLEMENTATION

Community development programmes require a multi-sectoral approach that involves various stakeholders including MDAs, LGAs, legislature, CSOs, community members, Development Partners, media, faith-based organisations, organised private sector etc. Consequently, the implementation of this policy will require close collaboration among these sectors. Their roles and responsibilities in the implementation of this policy are outlined below:

## **Role and responsibilities of MDAs**

Through collaborative efforts and coordination mechanisms the relevant MDAs will have responsibilities for the successful implementation of this policy as follows:

### **Adamawa State Planning Commission (ASPC)**

Responsible for the overall coordination and oversight of policy implementation as well as appraising the policy environment, gauging the level and quality of stakeholders and evaluating outcomes of implementation

### **Ministry for Information and Strategy**

Lead coordination of information management, mobilisation and sensitisation activities as well as creating feedback channels

### **Ministry for Local Government**

The ministry shall liaise with the ASPC for integration of CDPs into the state capital budget and financing of the implementation of the policy at the LGA level as well as balancing opposition demand toward policy implementation

### **Ministry of Agriculture**

Lead coordination of projects related to agriculture

### **Ministry of Works**

Provide technical support for infrastructure such as roads, culverts etc

### **Ministry of Women Affairs**

Ensure Gender and PLWD mainstreaming into the CDP process and programmes/projects identified by communities

### **Ministry of Health**

Provide technical input and oversight on health programmes and infrastructure

### **Ministry of Water Resources**

Provide technical support for the provision of safe drinking water and water for irrigation services

## **Adamawa State Rural Water Supply and Sanitation Agency (ADRUWASSA)**

Collaborates with the Ministry for Local Government Affairs, the Ministry for Water Resources and the 21 LGAs and takes the lead on issues of provision of safe water drinking water and water for irrigation services.

## **The Adamawa State Primary Health Care Development Agency (ADSPHCDA)**

Collaborates with the ministry for local government affairs and the 21 LGAs on all issues concerning primary health care services delivery as reflected in the CDP plans.

## **The Adamawa State Community and Social Development Agency**

Shall collaborate with the Ministry for Local Government Affairs to provide social services to the rural communities

## **Ministry of Livestock and Aquaculture Production**

Lead coordination of projects related to livestock and aquaculture

## **Role and responsibilities of LGAs**

The 21 LGAs shall be responsible for the following:

- ◆ Coordinating policy implementation at ward and community levels - coordinate the conduct of Ward CDP sessions and collation of plans
- ◆ Provide capacity-building support to WDSCs
- ◆ Coordinating the implementation of projects at community level
- ◆ Appraising policy environment at community level
- ◆ Supporting the implementation of the CDP process at community level
- ◆ Gauging the level and quality of stakeholders at community level
- ◆ Providing financial support and implementation at community level
- ◆ Evaluating outcomes of implementation at community level
- ◆ Integrating the Community Development Plans into the budget
- ◆ Monitoring and Supervising activities, services and programmes being implemented at the grassroots
- ◆ Mobilizing resources for policy implementation
- ◆ Timely release of funds for implementation

## **Role and responsibilities of community members**

- ◆ Active participation in articulating community needs and problems during Ward CDP sessions
- ◆ Lobbying for implementation of projects
- ◆ Take ownership of the project

- ◆ Sustain the project
- ◆ mobilising resources for the implementation of projects
- ◆ Ensure monitoring supervision and security of the project
- ◆ Hold political office holders/ government stakeholders accountable
- ◆ Awareness creation amongst themselves on projects

### **Role and responsibilities of Legislature**

- ◆ Advocacy and stakeholder engagement
- ◆ Building Capacity of different stakeholders
- ◆ monitoring transparency and accountability in the use of resources
- ◆ Providing feedback on policy implementation

### **Role and responsibilities of Development Partners**

- ◆ Building Capacity of CSOs and government partners
- ◆ Providing technical assistance and institutional support
- ◆ Providing project implementation manuals/modules/appraisal documents
- ◆ Providing funding support
- ◆ Monitoring accountability of funding provided

### **Role and responsibilities of organized private sector**

- ◆ Provide support to community initiatives
- ◆ Provide funding to community projects

- ◆ Initiate and implement community-focused projects based on Ward CDP plans
- ◆ Create awareness of developmental projects
- ◆ Partner with other development partners
- ◆ Promote human capital development of community members
- ◆ Provide technical support/assistance to community members
- ◆ Develop and maintain infrastructure and services

### How to mobilise resources for the implementation of the policy

## Partnership Arrangement

To be more effective and efficient, as well as to maximise resources, the State Government should enter into partnership with relevant organisations in the implementation of the policy. Partnership Mechanism/instrument e.g. MoU to be developed and signed by the respective parties. Responsibilities should be shared between the participating agencies and partners, based on the technical area of the mandate

## Capacity Building

- ◆ Training, sensitization, and advocacy for stakeholders should be adopted periodically.

# APPROVAL

The approval of this policy and any future reviews shall be by the Executive Governor of Adamawa State.

# MANAGEMENT OF POLICY RECORDS

## Storage of Policy Record

Policy records will be stored for easy access to stakeholders throughout the state

- ◆ The policy documents shall be accessed free by the stakeholders aside from the cost of printing and photocopy if necessary.

## Where and how to access policy

- ◆ The stakeholders shall access the policy documents by applying through the Ward Development Support Committees, the relevant department in the Local Government, through the website of the Adamawa State Planning Commission or at the various libraries across the state.

# MONITORING AND EVALUATION

Monitoring and Evaluation is a major aspects of the implementation of the policy. Monitoring is the routine process of data collection or tracking of the day-to-day activities and measurement of progress to determine the extent to which a project or programme has been effectively implemented at different levels, in time and at what cost toward programme objectives. Evaluation on the other hand is the systematic objective analysis of a project's performance, efficiency, and impact in relation to its objectives. It measures the medium-term and long-term results and is conducted at one or more points during the programme period – usually at the **mid-point** or **end** of the programme term.

## Monitoring

Monitoring the implementation of the policy is critical to ensuring compliance. Government agencies and relevant stakeholders to be involved in monitoring and evaluation of the implementation of the policy are listed below:

## **Method of Monitoring and Evaluation**

Method is a procedure or systematic way of doing something, an established and systematic way of carrying out a particular action. Both quantitative and qualitative methods shall be applied in collecting data and information in the monitoring of the implementation of this policy. For example, use of population census, community meetings (town hall meetings), ranking, rating, participant's observation, stakeholder analysis, documents review, community dialogue, focus group discussion (FGD) and in-depth interviews to obtain quantitative and qualitative data. Baseline, Mid-term, and End-term evaluations shall be conducted. A consultant can be engaged for evaluation.

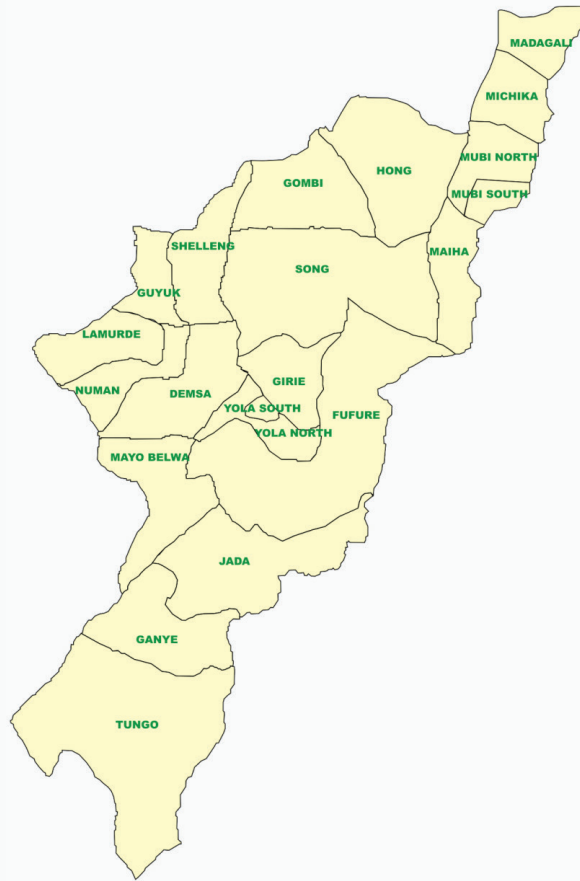
