Tunisia begins trade under the AfCFTA


On 25 May, coinciding with Africa Day, the first shipment under the AfCFTA successfully made its way to Cameroon, heralding a new era of South-South cooperation and a major step forward in economic integration between African countries.

This first successful experience of exporting under the "Guided Trade" initiative, with the AfCFTA preferential rate, initially attracted the interest of 10 Tunisian companies to take advantage of the benefits of this agreement by exporting with AfCFTA certificates of origin.

Up to October 2023, 19 export operations to Ghana, Cameroon and Tanzania have been carried out by Tunisian companies covering various sectors such as construction, agri-food and the chemical industry, with a reduction in customs rates thanks to the application of the AfCFTA Agreement.

To date, 37 AfCFTA certificates of origin have been issued by Tunisia's chambers of commerce and industry.







Support to negotiate and implement Phase II of the AfCFTA

Consultation workshop on the 5 protocols of phase II of the AfCFTA



On 25 October 2023, a consultation workshop was held to discuss the five (5) protocols of phase II of the African Continental Free Trade Area (AfCFTA) agreement.

This event brought together the focal points responsible for negotiating these protocols, as well as representatives of the private sector. During the workshop, the focal points presented the latest versions of the draft protocols currently being negotiated, as well as the protocols already adopted for phase II of the AfCFTA.

Discussions focused on the key role played by the private sector in these negotiations, as well as Tunisia's position in relation to the resolutions of these protocols.

The objectives of the workshop were to:

- To brief private and public sector representatives on the latest rounds of negotiations under Phase II of the AfCFTA.
- Facilitate a debate between private and public sector representatives on issues related to transparency, quantitative restrictions and discrimination as addressed by the protocols of phase II of the AfCFTA...

Institutionalisation of the AfCFTA National Committee in Tunisia: Review of the mission of the delegation representing the National Committee in Ghana





The reference trip of the core group of the AfCFTA National Committee from Tunisia, which took place in Accra from 19 to May 2023, aimed to understand and evaluate Ghana's experience in implementing its national AfCFTA strategy.

A number of official visits were organised during the trip. During the mission, the core members of the national committee met with the AfCFTA Secretariat and the Central Bank of Ghana, and also visited the port of Tema and the Ghana Special Economic Zone. The representatives of the AfCFTA national committee were also received by His Excellency Wamkele Mene, marking a historic moment as the first national committee to have made this meeting.

These moments of interaction fostered a deeper mutual understanding of the issues, laying the foundations for an even closer and more harmonious collaboration.

The diversity of viewpoints and skills present at the meetings enriched the discussions, offering a multi-dimensional perspective on the challenges and opportunities ahead, in the spirit of the collective commitment to develop South-South cooperation through the effective implementation of AfCFTA.

Institutionalisation of the AfCFTA National Committee in Tunisia: First meeting of the AfCFTA national committee



On 14 December 2023, under the aegis of Ms Lamia Abrouk, Head of the Cabinet of the Minister of Trade and Export Development, the first meeting of the National Committee responsible for negotiating and monitoring the implementation of the Agreement establishing the African Continental Free Trade Area (AfCFTA) was held.

The Committee comprises representatives from the public and private sectors. A presentation was made on the most important provisions of the Agreement, highlighting the mechanisms and privileges it grants to economic operators, the extent of the progress made in bringing the Agreement into force and guaranteeing the activation of all its provisions, as well as listing the cooperation projects available to support Tunisia in negotiating and implementing the Agreement.

It was also agreed at this meeting to set up five working teams according to the topics under negotiation and according to the priority sectors of the AfCFTA General Secretariat, such as the textile, clothing, automotive components and services sectors, including a working team concerned with monitoring the implementation of the project to rehabilitate the Ras Jdir border post as part of its upgrading and the objective of making it a gateway to Africa

Support for customs: Tunisia's customs directorate commits to implementing the AfCFTA and COMESA agreements







Two awareness-raising conferences on the African Continental Free Trade Area (AfCFTA) Agreement for the benefit of its executives and customs officers were organised in Tunis on 06.05.2023 and RAS JDIR on 05.07.2023, under the theme: "Accelerating the implementation of the AfCFTA in Tunisia: What is the role of customs?".

These events were part of the finalisation, on 6 April 2023, of all the legal procedures and technical conditions necessary for the Tunisian side to begin commercial operations under the AfCFTA Agreement. These awareness-raising conferences, attended by nearly 200 officers, were also an opportunity to:

- Highlight the role of public institutions in developing exports to Africa. Raise awareness among customs officials of the specifics of the AfCFTA and their role in its implementation.
- Promote the DGD's capacity-building activities
- Promote the results achieved with the support of the AACA project.
- Encourage the creation of synergies and exchanges between public and private sector players.

Support for customs: Launch of a specific training program on AfCFTA and COMESA rules of origin:50 officers from the Directorate General of **Customs trained**



As part of the Support for Trade Agreements with Africa project in cooperation with the Ministry of Trade and Export Development (MCDE) and the Directorate General of Customs (DGD), four (4) national intermediate and advanced training workshops on the AfCFTA and COMESA rules of origin in Sfax and Tunis from 12 to 21 October 2023 and Djerba and Tunis from 11 to 16 December 2023 were organised, with the participation of some fifty (50) customs officers from different units and regional directorates.

During the workshops, participants worked on the key concepts of correct origin determination, related operational and procedural issues and the implementation of effective origin management. In addition, the trainers, Customs Colonel Major Mohamed Rabie Belhadi, Director of the Origin Directorate within the General Directorate of Customs, and International Expert Stefan Moser, commissioned by GIZ-Tunisia, presented the guidelines on certification of origin, verification of preferential origin, risk assessment and risk management. Participants also discussed specific points such as certification, verification and administrative cooperation.

At the end of these courses, a group of 10 to 12 trained origin experts will be selected to follow a training of trainers' course starting in January 2024.

Support for customs: Institutional mission of the Tunisian Customs DG to Kenya and Tanzania







From 6 to 13 November 2023, a high-level delegation composed of officials from the Tunisian Customs Department and a representative of the Ministry of Trade visited Kenya and Tanzania. The aim of this technical visit was to exchange best practices on customs procedures and the integrated and coordinated management of trade within the framework of the African Continental Free Trade Area (AfCFTA) and the Common Market for Eastern and Southern Africa (COMESA) agreements.

The meetings also focused on trade facilitation in the work of customs authorities and on continental connectivity, using the corridor approach and the Guided Trade Initiative (GTI) to link the North and the South-East and open up new business opportunities for Tunisian economic operators.

The Tunisian delegation met a number of government agencies, including the Kenya Revenue Authority, TradeMark Africa, the Kenya Trade Network Agency (KenTrade), the onestop border post at the border in Namanga (Kenya) and in Arusha (Tanzania), the Tanzania Revenue Authority (TRA), the General Secretariat of the East African Community, as well as representatives of the GIZ Tanzania & EAC support programme, based in ARUSHA.

Support for customs: Capacity-building in tariff classification: The World Alliance for Trade Facilitation and the World Customs Organization are supporting Tunisian customs in capacity-building in tariff classification: 25 certified customs officers

In cooperation with the World Customs Organisation (WCO), two sessions of intermediate and advanced training in the harmonised system for Tunisian Customs officials were held in Tunis from 23 to 27 October 2023 and from 11 to 15 December 2023.

The training courses enabled customs officials to deepen their understanding of the harmonised system in preparation for the implementation of the advance ruling mechanism.

The implementation of the "advance ruling" aims to improve transparency and predictability for economic operators and to reduce differences concerning tariff classification.

Support for Chambers of Commerce and Industry -Training on the AfCFTA and COMESA Agreements, Rules of Origin, Digitalisation of the issue of **Certificates of Origin (e-CO)**







At the request of the Tunisian Chambers of Commerce and Industry, the competent authorities in Tunisia for issuing AfCFTA and COMESA certificates of origin, the Ministry of Trade and Export Development (MCDE), with the support of GIZ-Tunisia, organised a series of national training workshops for the Chambers and member economic operators.

Their aim was twofold: on the one hand, to strengthen the authorities' skills in issuing certificates of origin, and on the other, to encourage dialogue between the various stakeholders, particularly entreprises, to understand and tackle the practical challenges of certification of origin. These workshops aim to:

- Increase the use of tariff preferences under these agreements.
- Strengthen expertise in issuing and control issues, post-verification of proofs of origin, and knowledge of cooperation with other customs administrations.
- Facilitate and improve compliance with RoO requirements and identify new export opportunities and the development of regional value chains.
- Contribute to the implementation of the AfCFTA and COMESA Agreements in Tunisia.

Public-private dialogue as part of the negotiation and implementation process

Thematic PPD workshop on the institutional framework of the FTAA and its good governance practices

On 06 June 2023, a thematic public-private dialogue workshop was held on good practice in institutional governance. During this session, the composition of the Tunisian National Committee of the African Continental Free Trade Area was examined in collaboration with the various stakeholders from the public and private sectors.

A comparative continental analysis of national committees in other AfCFTA member states was presented and discussed, providing an initial basis for reflection on the composition of the Tunisian National Committee.


Several recommendations emerged from this session, including the need for:

- Regular consultations: The Committee should organise regular consultations with relevant stakeholders, including private sector representatives, civil society organisations, trade experts and Member State governments
- Monitoring implementation: The Committee should establish a monitoring mechanism to assess the effectiveness of the actions undertaken.
- · Capacity building: It is crucial to strengthen the skills and knowledge of public and private sector actors to ensure mutual understanding and more effective collaboration.

6th edition of the Financing Investment & Trade in Africa (FITA 2023) international conference: Support for Africa Trade Agreements Panel on AfCFTA









Under the High Patronage of His Excellency Mr. Kaïs Saïd, President of the Republic of Tunisia, represented by H.E. Mrs. Sihem Boughdiri, Minister of Finance, the 6th edition of the Financing Investment and Trade in Africa (FITA 2023) International Conference, held from 20 to 21 September 2023, hosted a unique panel on the African Continental Free Trade Area (AfCFTA) under the theme: "AfCFTA, the implementation phase of the agreement for Tunisia".

Moderated by Ms Amal Mghirbi, AACA Team Leader, this panel provided an opportunity to take stock of Tunisia's negotiation and implementation of the Agreement, and in particular to retrace the steps involved in obtaining the first AfCFTA certificate of origin issued by the Tunis Chamber of Commerce and Industry to PROKIM for a shipment to Cameroon.

Mr Lazhar Bennour, Director General of Economic and Commercial Cooperation at the Ministry of Trade and Export Development, and Ms Najet Jouadi, Director General of Customs, were the main speakers on the panel, along with Mr Radhouane Mekrazi, Director of the Central Entreprises Assistance Department at the Chamber of Commerce and Industry, CCI Tunis, and Mr Bedis Keskes, representative of PROKIM..

Completion of the ATO and ITC tool training series







Over the course of 2022 and 2023, the AACA project successfully orchestrated 10 training workshops in Tunis and the regions of Sfax and Monastir.

These training sessions were specifically designed to familiarise economic operators with the use of the ATO tool as well as other ITC tools, which are invaluable resources for exploring new markets, particularly in Africa, and within the framework of the AfCFTA.

A total of 231 participants from both the public and private sectors attended, demonstrating the level of commitment and interest in these capacity-building initiatives.

These workshops not only offered practical and operational skills, but also provided forums for the exchange of ideas and the creation of synergies that are essential for stimulating regional and continental economic growth.
