on lessons learnt under Technical Cooperation (TC) Project

An experience sharing workshop to showcase the achievements and lessons learnt under the GIZ supported Technical Cooperation (TC) project "Socio Economic Empowerment of Tribal and Rural Poor and Protection of Natural Resources, Tripura" under the aegis of Indo-German Development Cooperation (IGDC) took place in Agartala, Tripura on April 25th, 2014. Dr Rajeev Sharma, Programme Manager GIZ, gracefully moderated the workshop.

#### The prime objectives of the workshop were:

- to showcase the challenges, achievements and lessons learnt under the TC project;
- to demonstrate workable models, approaches, strategies that Govt. of Tripura and IGDC – FC project could potentially adopt in future;
- to trigger collaboration between various stakeholders in the up-scaling and replication of the approach.

Dr V. K. Bahuguna, Principal Secretary, Govt. of Tripura as Chief Guest in presence of Dr Hansjörg Neun, Programme Director GIZ, Mr Sanatan Talukdar, PCCF, Mr G. S. Raju, CEO JICA, Dr Ashok Kumar, Addl. PCCF and Mr Peter Laubmeier, Team Leader (TC) inaugurated the workshop with lighting of the lamp.

Representatives from line departments, bilateral agencies, commercial banks, private sector and civil society organizations also participated in the workshop.

Dr Bahuguna, in his inaugural speech said Tripura is a well-governed state and it is not primarily lack of funding – so why did we go for external aid? We need new ideas, initiatives and experiences aiming at livelihoods' generation for rural people. We should not only serve beneficiaries near the roadside, but everywhere. His very critical review stated "the two IGDC projects alone do not lead us to the objectives". There is need of better communication at grass-roots level, better capacity building and spreading the models from TC to other areas. He acknowledged that the two projects have brought lot of changes to strengthen development initiatives and capacities of many officers and that this workshop was very timely.

Dr Bahuguna also interacted with the community members to hear from them how they perceived TC project's support. Several members expressed their satisfaction with the good work being initiated under Mr Peter's leadership.

Dr Hansjörg Neun thanked the TC team for their hard work, for their achievements and stated that the TC team has lot of experiences to share. For setting the stage he showed the beauty of the TC project with selected pictures to illustrate the work on the ground.

Mr Peter Laubmeier in his technical presentation gave an overview on TC project's interventions with pragmatic examples highlighting a) challenges and issues; b); what did TC do? c) main achievements and lesson learnt, and d) How can it be scaled up? The audience appreciated the clarity of the format and given examples. Mr Laubmeier responded to the queries with utmost honesty and simplicity witnessing the deep insight and understanding of challenges at grassroots level. He drew the attention of the participants to the information and knowledge products compiling the TC project's work done during the the last five years shared during the workshop in both hard and soft copy versions.

#### Virtual Field Visits

A Short film on the Technical Cooperation initiatives in the state of Tripura offered the flavor of the TC endeavor that captivated the audience.

## **Experience Sharing**

Mr Satyendra Reang, Ms Ujjala Debbarma, Mr Bijoy Sen Chakma and Mr Naresh Debbarma represented the community associated with TC interventions and shared their positive experience of working together with project team members, the benefit they derived in terms of awareness and confidence building.

Certainly the audience acknowledged the need for continued handholding support in the state of Tripura. The community representatives were enquired on relevance, type of support, economic gain, sustainability of interventions, replication of measures, etc. which the members responded confidently. Finally, the house applauded the remarks made by the community members as it focused on key impacts and learning through IGDC – TC.

## A Journey through establishment of turmeric cluster

Mr Prattap Datta and Mr Selim Reza (GIZ TC team) made a joint photo presentation of their journey in setting up a cluster in one of the difficult locations of the region. The days were not as smooth as it seems to be today. There were heap of challenges with regard to availability of land, accessibility, provision of electricity, water etc. both in the Chakma and Reang belt.

Following the principles of Participatory Rural Appraisal (PRA) and its application, the cluster was organized and Government provided the land for construction of a processing centre for the cluster. Later the strong technical support of Dept. of Horticulture and Spice board build the awareness level of the cluster members. The exposure visit to Meghalaya proved to be the greatest confidence booster for the community, which led to the start of joint activities. Today, REMA Multiprocessing centre caters the needs of adjoining farming community for planting material as well as it provides facilities for processing of dried turmeric.

This experience was highly appreciated by the house and opened the doors of communication and collaboration amongst scientists, development practitioners, banks and others.

## Way Forward

Ms Sangeeta Agrawal, Sector Specialist, NRM, KfW focused on key takeaways for the remaining period of FC support under IGDC (end Dec. 2016) namely:

- Financial Cooperation project under IGDC shall organize similar experience sharing workshop by end Dec'14;
- FC will take forward the TC's business models of turmeric, fishery and egg layering;
- FC will take over the current 31 SHGs under TC project support and shall integrate ongoing livelihoods and loaning processes as provisioned under FC;
- SHG assessment tools of TC shall be applied across FC project;
- Strengthen capacity of VDPIS / panchayats in the implementation of village development plans (VDPs) resulting in improved convergence;
- Explore the possibilities of associating FC with competent NGOs to support implementation process.



## Share4change

An interactive video presented the new information and knowledge portal "Share4Change.org", a portal initiated by the Umbrella Programme on Natural Resource Management (UPNRM). This virtual platform empowers users to share their field-based knowledge, experience and lessons learnt in the areas of natural resource management (NRM) from India and disseminate the content effectively, globally and free of charge.
