# Decentralised Development Lab (DDLab)

The DDLab, part of the German Government and Federal States Programme (German: Bund-Länder-Programm, BLP), uses innovative and agile methods to work with German federal states and partner countries on issues that will shape the future of development cooperation. A number of topics were identified in a call for challenges, after which an international jury selected four challenges, for which ideas for solutions were sought in a next step. About 200 ideas for possible solutions were submitted by a wide range of international teams consisting of three to six people. Four promising ideas were selected to be further worked on in an incubation process. The fine-tuned proposals for solutions were presented to a jury at a pitch event. The winning ideas are receiving support from the BLP to help pilot and implement their solutions.

#### **Cooperation arrangements**

The DDLab builds on and expands the BLP's existing stakeholder landscapes. The project focuses on involving the German federal states and partner countries as peers. Accordingly, submissions to the Call for Challenges were received from federal states and partner countries. The four selected challenges were then specified in greater detail through a series of workshops with those representatives from federal states and partner countries that submitted them (so called "challenge owners"). During these workshops agile methods were used to develop specific questions and descriptions for the identified challenges.

As the incubator and the implementation processes continue, the challenge owners from the federal states and partner countries are all equally involved and feed in their own perspectives and expertise into the process of developing solutions. The DDLab project is being implemented with the support of enpact e.V. and minds & makers.

#### What we are doing - and how

The DDLab is an agile and innovative process that applies corresponding methods. The process builds on methods from the start-up sector, such as lean management and design sprints, to develop ideas that can be implemented sustainably and effectively in the respective partner countries.
