B. Project Background

The "India-EU Water Initiative (IEWI)" is jointly co-financed by the EU and BMZ and implemented by GIZ as part of the BMZ project "Support to Ganga Rejuvenation (SGR)". The duration of the project is 36 months. IEWI supports and provides secretariat functions to the "India-EU Water Partnership (IEWP)", launched in 2016 to enhance cooperation between India and EU on water issues, including 'Clean Ganga' programme of the Government of India. The Specific Objective of IEWI action is strengthened technological, scientific and management capabilities of India in sustainable modernisation and management of water resources, including through joint EU-India businesses, states, regions and/or cities initiatives in the water sector. There are three main outputs of the action: (1) strengthening policy dialogue between India and the EU on global issues of the water sector is strengthened through policy exchange, improved coordination on water cooperation and streamlining involvement of selected EU Member States in Indian water initiatives; (2) strengthening technical, scientific and management capabilities of key stakeholders at central (CWC, CGWB, NMCG) and basin (state) levels towards managing the river basins, urban flooding and impacts of climate change; (3) capacitating RBM committees and water institutions to implement measures for river basin management and to identify appropriate technology solutions.

C. Responsibilities

As a Junior Water Resource Advisor, you will be responsible for supporting the technical team in implementation of activities with the Central Water Commission (CWC) and state governments of Tapi basin focusing on establishment of a Tapi Basin Committee and a platform for business involvement in water sector.

D. Core Scope of Tasks

Supporting the IEWI project manager and technical team in achieving objectives of the project.



- Support coordination between the Indian partners, the EU experts/consultants and all other involved to achieve the identified overall aims.
- Organize events, meetings, study tours and visits to project sites and develop reports related to the activities of the IEWI Action.
- Coordinate with partner and participating ministries for full participation and cooperation.
- Compile information on partner agreements (minutes of meetings), programme activities and outcomes to ensure knowledge transfer.
- Develop a monitoring system for IEWI in line with EU requirements and monitor progress of activities;
- Develop Terms of References related to thematic areas of the IEWI Action:
- Contribute to implementation of the communication strategy of the project, develop communication products, record experiences and lessons learnt.

Other duties/additional tasks

- Support the project director in coordination of GIZ India water sector activities.
- Other Duties/Additional Tasks as may be assigned.

E. Required Qualifications, Experience and Competencies

- Masters/MSc/MTech degree in Water Resources Management or Urban Planning, or qualification in equivalent field.
- Knowledge of water resources sector in India, institutional actors' landscape.
- Strong organizational skills with the ability to prioritize tasks, work pro-actively, manage deadlines, handle multiple responsibilities simultaneously.
- Strong analytical skills.
- Excellent report writing.
- Good team player.
- Excellent communication and interpersonal skills to effectively engage with diverse stakeholders, including government officials, project partners, and consultants.
- Willingness and ability to travel to project sites (Maharashtra, Gujarat, Madhya Pradesh and other locations)
- Proficiency in written and spoken English; knowledge of local languages would be an advantage.
