in order to provide support for development and delivery of Capacity Building activities to the key stakeholders in the health, education, labour and employment sectors on topics related to climate change and sustainable development.

The aim of the Project is to straighten climate change capacities of national institutions and to shift towards sustainable human capital development in the sectors of health, education, and labour and social protection. The project is implemented by the GIZ Office in Skopje and the Cabinet of the Deputy President of the Government in charge of economic affairs, and it is financially supported by the Green Climate Fund Readiness and Preparatory Support Programme. The duration of the project is 24 months.

Task of the expert include:

- Review and analyse institutional policies and organizational gaps for climate change mainstreaming within the Education Sector, focusing on the Ministry of Education and Science (MoES) and the Bureau for Development of Education (BDE).
- Prepare and deliver training on sustainable development and climate change.
- Assess best practices, policy gaps and develop recommendations for the integration of education for sustainable development and climate change topics (and their intersection with SDGs) in primary and secondary education (including VET), and higher education.
- Develop an Action Plan for integration of education for sustainable development (ESD) and climate change mainstreaming into primary and secondary education (including VET), university and adult education.
- Conduct and support the consultation process by organizing meetings, trainings, and workshops with the relevant stakeholders, in the country and online.

2.	<u>Professional experience:</u> - 5 years of professional experience in climate change, education, sustainable development, and/or educational capacity development.	
3.	<u>Specific Experience:</u> (a) Proven working experience of 4 years in the field of policy and strategy analyses, institutional structural analysis, project/ programme implementation in the field of climate change, education, sustainable development, and/or educational capacity development. (b) Knowledge of the educational system in the country, especially the process of curriculum development and teaching materials (tools). (c) Proven experience of 4 years in conducting capacity development activities for ministries or institutions, training material development and training delivery in the field of climate change, sustainable development, and/or education.	
4.	<u>Language:</u> - Business fluency in English; Excellent oral and written communication skills and ability to report clearly both verbally and in writing on English.	
5.	In the past five years the expert has implemented at least 1 similar assignment in North Macedonia (including reference for the assignment).
