Subject: Implementation of a regional multistakeholder project to upscale the platform on eCommerce for the CEFTA region

The project EU4Business: Support to Regional Economic Integration implemented by GIZ on behalf of the European Union (EU) and the German Federal Ministry of Economic Cooperation and Development (BMZ) aims to strengthen regional economic integration among the Central European Free Trade Agreement (CEFTA) markets by supporting the implementation of the Common Regional Market Action Plan (CRM AP) in electronic commerce. The project is part of the GIZ Open Regional Fund – Foreign Trade. Within this assignment, the eCommerce Platform <https://e-commerce4all.eu/> will be extended in collaboration with stakeholders from the eCommerce sector in all CEFTA markets. The activities will encompass the following:

- Designing and integrating a "Regional Trust Mark" Module.
- Extending the "E-Payment and Delivery" modules to four additional markets.
- Updating the existing data module for all markets.
- Joint development of a concept to ensure the platform's sustainability in the long term.
- Continued promotion of the platform at a regional level.

Minimum participation criteria

1. Legal entity registered in North Macedonia
2. Average annual turnover for the last three financial years at least 20.000,00 EUR
3. Experience in delivering multistakeholder projects in the area of eCommerce
4. Average number of 2 employees for the past 3 years
