General information

a. Brief information on the project

Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) has been mandated by the German Federal Ministry for Economic Cooperation and Development (BMZ) to implement a global project operating under the title "Supporting sustainability aspects in the implementation of EU Economic Partnership Agreements (NEW)" in order to foster EPA implementation by regional organisations, their member states, the private sector and civil society in a way that supports sustainable development. The first phase of the project was implemented during the period of May 2017 to April 2020, the current phase is commissioned to run from May 2020 until February 2024. The project operates cross-regionally, with a focus on Southern Africa (SADC EPA), Eastern and Southern Africa (ESA EPA) and the Caribbean (CARIFORUM EPA).

The GIZ NEW project's interventions are organized around three main areas:

- (1) Facilitating the establishment of participatory EPA monitoring systems, providing methodological as well as institutional support. (Output area 1)
- (2) Strengthening the capacity of public and private sector actors to (a) make best use of the potentials of the EPA for sustainable development and to (b) recognize and mitigate potential risks for sustainable development. (Output area 2)
- (3) Developing cross-regional exchange of public and civil society actors on implementing and deepening the EPAs with a view to supporting sustainable development. (Output area 3)

b. Context

At the design stage of the current phase of the NEW project, desired project results were defined on output and outcome level and respective indicators were agreed with the commissioning party (BMZ): Results at outcome level are to be measured by five so-called "Module Indicators", results at output level by five output indicators. Please refer to the Annex "Results Matrix" for further details.

To measure progress towards the indicators and to capture evidence the project has set up an internal monitoring system, tracking milestones and progress towards indicator achievements in the project's intervention areas.

Two of the Module Indicators require an ex-post evaluation and thus have not been measured and assessed so far. The ex-post evaluation shall take place in 2023 and is at the center of this assignment.

c. Objective

The assignment, that is the subject of this tender, aims to assist the NEW project in its evaluation and evidence (data) capture for two (2) out of its five (5) module indicators (MI). These are NEW's module indicator 3 and 5. Module indicator 3 relates to Output 2 of the project which focusses on the SADC region, whereas module indicator 5 to relates to Output 3 that covers the CARIFORUM, ESA and SADC regions. The information on the aim, measurement, and sources of data for these two indicators, as approved by the BMZ during the project design phase, are as follows:

The aim of this assignment is to conduct the evidence/data capture as outlined in the sources section of both indicators.

In addition, the evaluation shall collect further information on Output indicators 2.1.,3.1 and 3.2 to triangulate and complement the information the project has already collected via standardized questionnaires at the end of each partner event. These output indicators are as follows:

Output indicator 2.1:

Out of 180 representatives of national agencies of the SADC EPA member states who are entrusted with implementing EPA provisions, 144 have confirmed that they have acquired significant new skills for implementing EPA provisions.

Output indicator 3.1

Thirty (30) of 40 civil society and public sector participants in supraregional exchange forums have confirmed that they have acquired significant skills to assess potentials and risks of the EPA for sustainable development in their region.

Output indicator 3.2

Thirty of 40 public sector participants in supraregional exchange forums have confirmed that they have acquired significant skills for negotiating deeper EPAs.

To fulfil the capacity development needs required to achieve these indicators, the NEW project has already been implementing a variety of measures throughout its implementation.

- For MI 3 and output indicator 2.1: several trainings on various aspects of EPA implementation were held in the SADC region. These targeted national officials. They are trainings on
 - o EPA safeguards
 - EPA Rules of Origin
 - EPA Monitoring
- For MI 5 and output indicators 3.1 and 3.2: the NEW project has implemented multiple cross regional exchanges and plans continue implementing these in 2023. Implemented exchanges are:
 - Trade in Services under EPAs (05/2022)
 - EPA Trade and Sustainable Development provisions (11/2022)
 - Involvement of civil society in the monitoring of EPAs (02/2023)

- Effects of EU autonomous measures on trade under the EPAs (08/2023)
- In-person cross-regional exchange on multiple topics (10/2023)

Given these implemented activities, the NEW project will provide to the Company the respective participants lists and contact details from the SADC trainings and cross-regional exchanges to identify potential interview partners for the evaluation of MI 3 and MI 5 and the relevant output indicators (2.1; 3.1; 3.2).

Furthermore, there are currently up to 2 in-person events being planned, that will likely bring together many of the relevant officials and past participants. Thus, these events can be an opportunity to conduct the relevant interviews in person. Currently the events are planned for Q4 2023. If applicable to the proposed data capture methodology and still relevant for the completion of all necessary interviews, travel budget for the participation at these events can be made available (see Chapter 3 below).

d. Expected results

At the end of the intervention, the following results/ deliverables are expected:

- Fianalized interview question catalogue verified by the GIZ NEW team
- Surveys and/or interviews have been conducted with 1) 50 representatives of national agencies from the SADC region and 2) 40 participants from cross-regional exchanges previously organized by NEW
- An overview of the examples provided by the 50 SADC national officials interviewed that demonstrate how their organisation's contribution to sustainable implementation of the EPAs has changed.
- An overview of the examples provided by the 40 participants of cross-regional exchanges that demonstrates how they have used the knowledge acquired at the events to contribute towards realising potentials of the EPAs or averting risks.
- Excel table containing per interviewee the interview results (questionnaire) and basic information on participants' characteristics (e.g. country/region, type of institution, gender) in anonymised form.
- Overview of examples from interviews of participants in cross-regional exchanges demonstrating how participants have used the inputs for ESA deepening negotiations or the SADC EPA Review (Reference to Ouput Indicator 3.2)
- Overview of examples from interviews with representatives of national institutions that participated in project capacity development measures, demonstrating how they have used the acquired know-how and/or the developed material on EPA Safeguards and Rules of Origin in their respective institutions (Reference to Output indicator 2.1)
- e. GIZ shall hire the contractor for the anticipated contract term, from 01.10.2023 to 31.01.2024.
- f. The contractor shall provide the following work/service:
 - Design an evaluation methodology for the surveying and/or interviewing of 50 SADC national officials and 40 EPA cross-regional exchange participants
 - Prepare, further refine (based on feedback from the NEW project) and finalize
 - A set of interview questions in English and Portuguese language
 - A format for capturing the examples and further data resulting from the interviews/survey including gender-disaggregated data collection
 - Draw up the logistical planning and schedule the required interviews
 - Conduct interviews of 50 SADC national officials and 40 EPA cross-regional exchange participants. Except where the contractor will be required to travel to interview participants at the up to two regional workshops in SADC (see section 4), all

interviews will be expected to be conducted remotely. The great majority of interviews will be conducted in English language. Interviews with officials from Mozambique shall be conducted in Portuguese language.

- In case that targets cannot be met, provide a report on the challenges and rationale behind the failure to meet the targets

On steering of this support:

- The contractor manages costs and expenditures, accounting processes and invoicing in line with the requirements of GIZ.

Data protection

2. Appropriateness of proposed concept

In the tender, the tenderer is required to show *how* the objectives defined (Tasks to be performed) are to be achieved, if applicable under consideration of further method-related requirements (technical-methodological concept).

The technical concept provided as part of the bid will be evaluated according to the following criteria:

- Understanding of the objectives and project needs (2.1)
- Understanding of the relevant partners and institutions involved. Demonstration of how the identified target audiences (i.e., interview partners) are best addressed and approached (2.2)
- Explanation of methodology to be used to facilitate the capture of the required monitoring and evaluation data (2.3)
- First work plan and draft proposal for outreach and scheduling of interviews (2.4)

3. Specification of inputs

Sustainability aspects for travel

GIZ would like to reduce greenhouse gas emissions (CO₂ emissions) caused by travel. When preparing your tender, please incorporate options for reducing emissions, such as selecting the lowest-emission booking class (economy) and using means of transport, airlines and flight routes with a higher CO₂ efficiency. For short distances, travel by train (second class) or e-mobility should be the preferred option.

If they cannot be avoided, CO₂ emissions caused by air travel should be offset. GIZ specifies a budget for this, through which the carbon offsets can be settled against evidence. The market for carbon credits is made up of a large number of providers, each with different claims as to their climate impact. The <u>Development and Climate Alliance</u> has published a <u>list</u> of standards. GIZ recommends using the standards specified there

4. Requirements on the format of the tender

The CV submitted for each expert can have a maximum of four (4) pages. The **concept** should not exceed five (5) pages. If one of the maximum page lengths is exceeded, the content appearing after the cut-off point will not be included in the assessment. External content (e.g. links to websites) will also not be considered.
