1. Context

The Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH is a German federal enterprise and service provider in the field of international cooperation for sustainable development with worldwide operations. Its corporate objective is to improve people's living conditions on a sustainable basis.

The International Climate Initiative (IKI) is the key instrument of the German government, led by the Federal Ministry for Economic Affairs and Climate Action (BMWK) with cooperation of the Federal Ministry for Environment Nature Conservation, Nuclear Safety and Consumer Protection (BMUV), as well as the Federal Foreign Office (AA), for the international financing of climate change mitigation, adaptation and biodiversity conservation. Under the IKI, the German government is closely cooperating with the South African (SA) government, a core partner country. The Just Transition to a Decarbonised Economy for South Africa (JUST SA) project is funded by the IKI through the BMWK and is implemented by GIZ.

JUST SA supports the implementation of pathways towards a Just Transition towards an environmentally sustainable, climate-change resilient, low-carbon economy and just society. At the national level, the project supports the implementation of the Just Transition Framework, ensuring an inclusive and results-oriented process. At regional level, the project assists the Mpumalanga provincial government in formulating a concrete, sustainable and just economic diversification plan for a diversified regional economy, which covers support for SMMEs and finance mechanisms. At the local level, the project implements, pilots and scales up activities in selected municipalities of Mpumalanga and private sector action is incentivised. Furthermore, mine rehabilitation is addressed with a focus on mine water treatment through research, policy implementation and community engagement. Lessons learnt are fed back into the dialogue process.

The JUST SA project recognises the significant challenges that accompany the transition towards an environmentally sustainable, climate-change resilient, low-carbon economy and just society. The project prioritises the inclusiveness of the transition process by working in partnership with the relevant stakeholders and ensuring that the transition has a positive impact on the livelihoods of all, especially those who are disadvantaged such as women and youth.

It is important that the just transition in South Africa as well as the information surrounding it reaches a vast majority of the people in affected regions. Media is a powerful tool to help accomplish this. According to the Broadcast Research Council of South Africa, approximately 23 million people in South Africa tune into radio each week, with the biggest radio community station in Mpumalanga being Nkomazi FM, with a listenership of about 91 000 listeners a week.

In recent years, podcasting has surged in popularity globally, including in South Africa, driven by widespread smartphone and internet access, leading to podcasts becoming a mainstream source of entertainment, information, and education. With approximately 28.99% of South Africa's population spending one to five hours per week listening to podcasts and platforms like YouTube, Spotify, and Google Podcasts being popular choices, the medium's versatility and accessibility are key factors in its rise. Furthermore, projections indicate that the number of South African podcast listeners will grow significantly, reaching 4.8 million by 2027 – up from 3.2 million in 2023.

Both podcasts and radio have the potential to reach a wide range of audience in Mpumalanga, while fostering participation and engagement on just transition topics.



General objective

JUST SA is aiming to launch a just transition podcast which will also be aired on radio within Mpumalanga and potentially other provinces. The podcast aims to improve the understanding surrounding the just transition in South Africa, particularly in remote areas of Mpumalanga, by providing a platform for engagement with stakeholders and experts and knowledge sharing. JUST SA is therefore looking for a service provider to develop and implement the podcast by writing script, finding guests, and hosting the podcast episodes at the recording studio. The service provider will also need to source and procure said podcast production studio to record and package the podcast in long and short formats.

Expected outcomes

The just transition podcast aims to engage with a wide audience in Mpumalanga, the project intends to improve understanding of the just transition in South Africa, and concepts around it by sharing information on the just transition, therefore, educating listeners.

The podcast provides a foundation of recorded facts that can be shared via our digital platforms with potential later distribution on community radio stations in Mpumalanga. The potential broadcasting on radio stations will allow for a platform for these communities in the remote parts of Mpumalanga to gain knowledge on just transition.

Target audience

The just transition podcast is targeted at communities in the Mpumalanga province impacted by the transition. The podcasts will be recorded and packaged and then aired by community radio stations in Mpumalanga via short inserts and adverts. They will be disseminated in English and isiZulu, the languages widely used in Mpumalanga. The modular nature of the podcast will allow for further distribution in other regions as the transition unfolds.

The podcast is aimed to appeal to a wide audience, such as youth, women, disadvantaged groups, the elderly, working as well as unemployed citizens, and rural communities in Mpumalanga.

Proposed format/structure

Podcast

The podcast will take on a talk show format where the host will interview and discuss various topics of a just transition. One or two guests representing stakeholders, technical experts, members of civil society or representatives from communities will be invited to engage with the audience through the podcast.

Listeners will get to engage with guests on topics through commenting on the podcast platform as well as on social media such as LinkedIn and X (formally known as Twitter), where the links to the podcast have been published, using the relevant tags and hashtags.

Each podcast episode will be 30 minutes long, with 30-second, 5-minute and 10-minute snippets extracted, and will be in video (MP4) and audio (MP3) format. The episodes will be produced over a period of 9 months and will be aired bi-monthly, over a period of 12 months. The publication of the episodes and subsequent snippets on 2 radio stations will be conducted by the service provider and submitted to GIZ for preapproval during the duration of their contract. Thereafter, GIZ will conduct the publication of episodes.



Radio

The podcast will be edited and packaged into bitesize, 15-minute audio episodes which will be aired on one or two community radio stations based in Mpumalanga. We have identified eMalahleni FM as one of the potential radio stations. There is also a potential for the snippets to be aired on mainstream radio. Some potential radio stations identified by the JUST SA team include, but are not limited to:

We would like the consultant to start with the community radio stations and explore mainstream media much later, the curated content (i.e. script, radio media plan) will first be shared with GIZ for preapproval before being aired on the radio stations and distributed to mainstream media.

For radio, listeners will also get to engage guests through social media. Some radio stations allow for WhatsApp interaction.

2. Tasks to be performed by the contractor

The GIZ is seeking a service provider to develop and host nine podcasts aimed to educate those directly impacted by the just transition over a period of 9 months. The expert will be responsible for writing the scripts for each episode, hosting the podcast and identifying topics, questions, and guests to talk about just transition in South Africa. The expert will also need to have at least two episodes in the most used language in Mpumalanga, isiZulu, as well as two episodes in both isiZulu and English.

The contractor is responsible for providing the following services:

I. Inception report

The expert will be responsible to develop a concise inception report that outlines the planning and process of identifying just transition topics and speakers for informative audio and video radio programme podcasts, to be aired via a podcast platform as well as on radio. The inception report should also include a radio media plan, identifying suggested radio stations based on the size of their audience and reach.

II. Outline of just transition podcast topics and speakers

The expert will be responsible to develop a detailed concept outlining the topics and content that will be covered in the podcast. It should also map out how they will source the best speakers for each respective episode. Proposed topics are:

While the above nine topics provide guidance, the expert will need to develop scripts (outlined in section III) for the eight episodes of podcast series. For this, they will need to research the most asked questions or find out where knowledge is lacking regarding the just transition in South Africa. An introduction to climate change has to form one of the topics where climate change is explained. This episode will be an introductory episode on what climate change is, and the various impacts that climate change has on individuals and communities.

Episode 1 in isiZulu needs to be general discussions, and not specialised, as it will cover just transition as a whole, rather than focused on the specific just transition topics. Episodes 3, 4 and 6 will also be in isiZulu, as we believe that it would be best to talk to the community, those most affected by the transition, in their local language.

Key deliverables:

 Concept which includes the format of the nine episodes, including topics and speakers.

III. Programme scripting, hosting and recording of podcast episodes

Once the expert has identified the topics, format and speakers for the just transition programme, they will then need to draft the script. After the script has been drafted, they will need to host the episodes while being audio and video recorded.

The expert will need to procure the services of a studio to record, edit and package the podcast into audio only, as well as audio and video. Each podcast episode will be 30 minutes long, with five-minute snippets extracted. The videos must be submitted in MP4 format, while the audio should be submitted as an MP3. We will also need a couple of photographs taken of the podcast guests and hosts during the recording, which should be submitted in JPG format.

Key deliverables:

 9-episode scripts developed and shared with JUST SA for input and approval before recording of each episode. Qualifying criteria:



- Each script should have an overview, a content section outlining key speaking points and a section included the identified hosts and participants, as well as the target date of recording.
- Procurement of recording studio
- Hosting of each of the nine episodes
- 12 full-length recorded audio and video files of each episode in MP3 and MP4 format
- 12 short snippets (30-seconds) recorded in MP3 and MP4 format
- 12 medium-length snippets (5-minutes) recorded in MP3 and MP4 format
- 12 extended snippets (10-minutes) recorded in MP3 and MP4 format

IV. Radio advertisements/teaser bookings

In addition to podcast production and hosting, the consultant will be responsible for booking radio advertisements and teasers to promote the JUST SA radio programme podcast. The teasers which will form part of the advertisements will be a snippet of upcoming episodes. The service provider will also reach out to the radio stations and book the adverts once the podcasts have been loaded on the JUST SA website while the service provider is still under contract.

Key deliverables:

- Target strategic advertising time slots and radio stations frequented by the Mpumalanga community.
- Create compelling teaser content to generate interest and anticipation for upcoming podcast episodes, effectively communicating the value and relevance of the content to the target audience. The criteria for acceptance of the teasers will be preapproval from the GIZ team before airing any of the teasers/ adverts.

3. Concept

In the tender, the tenderer is required to show *how* the objectives defined in Chapter 2 (Tasks to be performed) are to be achieved, if applicable under consideration of further method-related requirements (technical-methodological concept). In addition, the tenderer must describe the project management system for service provision.

Note: The numbers in parentheses correspond to the lines of the technical assessment grid.

Technical-methodological concept

Strategy (1.1): The tenderer is required to consider the tasks to be performed with reference to the objectives of the services put out to tender (see Chapter 1 Context) (1.1.1). Following this, the tenderer presents and justifies the explicit strategy with which it intends to provide the services for which it is responsible (see Chapter 2 Tasks to be performed) (1.1.2).

The tenderer is required to present the actors relevant for the services for which it is responsible and describe the **cooperation (1.2)** with them.

The tenderer is required to present and explain its approach to **steering** the measures with the project partners (1.3.1) and its contribution to the **results-based monitoring system** (1.3.2).

The tenderer is required to describe the key **processes** for the services for which it is responsible and create an **operational plan** or schedule (1.4.1) that describes how the services according to Chapter 2 (Tasks to be performed by the contractor) are to be provided. In particular, the tenderer is required to describe the necessary work steps and, if applicable, take account of the milestones and **contributions** of other actors (partner contributions) in accordance with Chapter 2 (Tasks to be performed) (1.4.2).

The tenderer is required to describe its contribution to knowledge management for the partner (1.5.1) and GIZ and to promote scaling-up effects (1.5.2) under **learning and innovation**.

Project management of the contractor (1.6)

The tenderer is required to explain its approach for coordination with the GIZ project. In particular, the project management requirements specified in Chapter 2 (Tasks to be performed by the contractor) must be explained in detail.

The tenderer must provide a clear overview of all proposed experts/interns and their individual qualifications.

5. Costing requirements

Assignment of personnel and travel expenses

Expert 1: Assignment in country of assignment for up to 57 expert days

- Research topics that should address various aspects of the just transition, such as policy impacts, community stories, economic opportunities, and environmental considerations.
- Compile a list of potential speakers for each episode, including experts, community leaders, industry representatives, and affected individuals.
- Draft report outlining the 9 just transition podcast episodes, topics and speakers. Detail the main themes, discussion points, and any special segments or features (interviews, roundtable discussions etc.).
- Draft podcast script ensuring content is clear, informative, up-to-date, relevant and engaging. Cross-check facts and sources to maintain credibility and reliability. Tailor language and tone to target audience. Scripts to be reviewed by JUST SA team.
- Procurement of podcast studio to record and package the podcast. Identify and evaluate studios.
- Radio advertisements and teaser bookings. Develop a strategy for radio advertisements, including key messages, target audience, and desired outcomes. Create engaging teaser content highlighting upcoming episode and a schedule for advert placements leading up to and during the podcast episode release. Identify and contact relevant radio stations to book advertisement slots.

Expert 2: Assignment in country of assignment for up to 57 expert days

- Assist with procurement of podcast studio to record & package the podcast
- Assistance with radio advertisements and teaser bookings

The service provider is expected to cost for up to 114 expert days as indicated above. These should also include **travel days**.

Per diem allowances are reimbursed as a lump sum up to the maximum amounts permissible under tax law for each country as set out in the country table in the circular from the German Federal Ministry of Finance on travel expense remuneration (downloadable from the German Federal Ministry of Finance – tax treatment of travel expenses and allowances for international business travel as of 1 January 20242025 (GERMAN ONLY)).

Accommodation allowances are reimbursed as detailed in the specification of inputs below.

With special justification, additional Accommodation costs up to a reasonable amount can be reimbursed against evidence.

All business travel must be agreed in advance by the officer responsible for the project

Sustainability aspects for travel

GIZ has undertaken an obligation to reduce greenhouse gas emissions (CO_2 emissions) caused by travel. When preparing your tender, please incorporate options for reducing emissions, such as selecting the lowest-emission booking class (economy) and using means of transport, airlines and flight routes with a higher CO_2 efficiency. For short distances, travel by train (second class) or e-mobility should be the preferred option.

CO₂ emissions caused by air travel must be offset. GIZ specifies a budget for this, through which the carbon offsets can be settled against evidence.

There are many different providers in the market for emissions certificates, and they have different climate impact ambitions. The <u>Development and Climate Alliance (German only)</u> has published a <u>list of standards (German only)</u>. GIZ recommends using the standards specified there.

6. Requirements on the format of the tender

The structure of the tender must correspond to the structure of the ToRs. The tender must be legible (font size 11 or larger) and clearly formulated. It must be drawn up in English (language).

The complete tender must not exceed 10 pages (excluding CVs). If one of the maximum page lengths is exceeded, the content appearing after the cut-off point will not be included in the assessment. External content (e.g. links to websites) will also not be considered.

The CVs of the personnel proposed in accordance with Chapter 4 of the ToRs must be submitted using the format specified in the terms and conditions for application.
