## A. RESPONSIBILITIES:

The Data Policy Technical Advisor will be embedded within AUDA-NEPAD and provide the organization with technical assistance to implement the AU Data Policy framework. The main responsibilities are as follows:

- Support the implementation of African Union's Digital Transformation Strategy for Africa 2030 and the Africa Union Data Policy Framework including:
  - o Support development of Continental Open Data Strategy
  - Support development of cross border data flow mechanism
  - o Assist in aligning regional instruments with Data Policy Framework
- Support cooperation between the African Union (e.g., AU Commission and AUDA-NEPAD) and the digital ecosystem actors in Africa and Europe

#### **B. TASKS**

The Data Policy Technical Advisor is expected to carry out the following tasks and advisory services (not exhaustive):

  - Support development of Continental Open Data Strategy
  - o Support development of cross border data flow mechanism
  - Assist in aligning regional instruments with Data Policy Framework
- Support cooperation between the African Union (e.g., AU Commission and AUDA-NEPAD) and the digital ecosystem actors in Africa and Europe
- Advise and provide technical assistance to the African Union Development Agency (AUDA-NEPAD), African Union Member states and Regional Economic Communities (RECs) on the development of a competitive regional digital economy and the implementation of the AU Data Policy Framework
- Assist in preparation of studies and strategies and develop mechanisms for harmonizing and monitoring the progress of data strategies, policies and regulations at continental, regional and national level.
- Organize workshops, study trips and events that provide knowledge and experience-sharing on implementation of data policies and offer networking opportunities for stakeholders
- Prepare and manage consultancy assignments and financing agreements and monitor service providers in completing their tasks.

- Initiate and foster partnerships with government, private sector, academia, and civil society actors across the AU and beyond for the project in the area of data governance and regulation
- Stay up to date with global and regional data policies, regulations, and trends, and provide guidance to AUDA-NEPAD accordingly
- Advise on the development of policies to ensure adequate data protection, sharing, access and interoperability mechanisms in African Union member states
- Work with government officials and policymakers to ensure that policies and regulations related to data management and sharing are in line with the African Union Data Policy Framework
- Collaborate with stakeholders such as civil society organizations and private sector entities to promote the integration of the African Union Data Policy Framework into their operations
- Organize delivery of training programs to stakeholders on data management and sharing best practices, and train data custodians within government agencies to create a cadre of data management experts.
- Monitor the implementation of the African Union Data Policy Framework across member states and provide regular status reports

- Experience working in data policy development, data management, or data governance
