

**INVOICING INSTRUCTION :**

GIZ standard payment term is WITHIN 30 DAYS after presentation of the following documents (COMPLETE CONDITION):

**1. Original Invoice by indicating :**

- Invoice shall be printed in the company letterhead with complete address with stamp and original signature.
- GIZ Purchase Order ref no.
- Project processing number/Cost centre
- Information of payment terms: Advance/Interim Payment/Final Payment
- Purchase Order Amount (excl. VAT)
- Copy of Bank Account

**2. Invoice and the requirements of supporting documents:**

**a. General Information**

- Items can only be invoiced as agreed in the Purchase Order
- The lump sum cost for any services, as agreed upon in the Purchase Order, is subject to income tax.
- Any advance payment (Down Payment) shall be supported with the Bank Guarantee
- Invoice starting from IDR 5.000.000, shall be signed with the duty stamp (Materai 10.000)

**b. Invoice shall be attached with the following documents:**

- **Delivery Order:** Delivery Order shall be provided by the Supplier and signed by GIZ
- **Handing Over Documents (Berita Acara Serah Terima)**  
Handing Over Documents attached with list of items shall be provided by the Supplier, signed by the Beneficiary (end user), and approved by GIZ.
- **Proof of documentation** (if any)

**3. Original Tax Form, with the following information :**

Please be informed that the format of the Invoice and Tax Invoice (Faktur Pajak) shall use the following format:  
Original Invoice addressed to: Project Name as stated in the contract (the Invoice should display the tax value).

**NOTES:**

- All prices/rates must be exclusive of all taxes, as GIZ, including its subsidiary organs, is exempt from taxes. GIZ shall process the VAT with tax exemption to BADORA. The process of tax exemption will take 2-3 months.
- Please mentioned the Purchase Order Number in the Tax Invoice (Faktur Pajak)
- The date of the tax invoice and the invoice should be the same.
- Please provide 2 copies of invoice (1 Original for payment) and (1 copy for the tax exemption process)
- Please be advised that GIZ does not have a Tax Identification Number, as GIZ (Kerjasama Teknik Jerman - RI) is registered as an international agency – a non-taxable company (Non-PKP). This is in accordance with the Ministry of Finance decree, KMK No. 17/KMK.010/2021.
