Supporting the joint project 'Flood and Drought Management in the Upper Tonle Sap Subbasin' between Cambodia and Thailand. This project mainly focuses on adapting to flash floods and droughts in the agricultural and fisheries sectors. Support includes developing an early warning system, identifying climate change adaptation solutions, implementing nature-based solutions, and developing a digital atlas and a master plan. Additionally, the project prioritizes sustainable green-grey investments. The project also supports plastic pollution monitoring, Core River Monitoring and supports MRC Strategic Plan 2021-2025 which includes advice on compliance mechanisms, internal controls, and efficient use of the funds from international donors and member countries.
