# Job Description Transport Policy Advisor (Category 4T)

#### **Project Description**

The International Climate Initiative (IKI) is an important part of the German government's international climate finance commitment. Since 2022, the IKI is implemented by the Federal Ministry for Economic Affairs and Climate Action (BMWK) in close cooperation with the Federal Ministry for the Environment, Nature Conservation, Nuclear Safety and Consumer Protection (BMUV) and the Federal Foreign Office (AA). The Philippines is one of the priority countries with which the International Climate Initiative maintains a close cooperation.

The project "Transformative Actions for Climate and Ecological Protection and Development" (TRANSCEND) responds to an IKI country call for the Philippines. The project is currently in its preparation phase and looking at implementation from 2024-2029. It will be implemented by a consortium led by the Climate Change Commission and the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH. The consortium partners include UN organisations, NGOs and academia. Centered around a holistic approach, TRANSCEND targets integrated solutions in climate adaptation, emissions mitigation, and biodiversity conservation across three distinct landscapes within the Philippines. In applying a "whole-of-society" strategy, the project pilots a comprehensive transition to a society that is resilient to climate impacts, lowers carbon emissions, and fosters biodiversity. On a local level, community-based planning and conservation initiatives aim to enhance natural carbon sinks and fortify the resilience of local government units. Decision support systems, adopted across all layers of governance, are intended to refine policy decisions and improve the efficacy of climate financing.

Within the broader framework, TRANSCEND also facilitates the International Climate Initiative Interface in the Philippines. This platform serves to coordinate networking events and disseminate regular updates through newsletters, thereby keeping both the German commissioning ministries and the German Embassy in Manila well-informed.

## **Main Role**

The Transport Advisor within the TRANSCEND initiative assumes a multifaceted role as a subject-matter expert in the domain of transport and climate change mitigation policy. The incumbent suited for this role should have a strong background in transport systems, climate change mitigation, and sustainable development. This role involves providing specialized advice on climate issues to stakeholders at both the national and local levels, while also supporting the project's transport and IKI Interface component through effective communication and advocacy.

# **Major Functions/Duties**

The incumbent performs the following major functions/duties:

#### Technical Advisory:

- Develop and advise on national policy frameworks related to public transport, electrification, and sustainable development.
- Synthesize strategic policy advice on financing mechanisms for public transport modernization and electrification.
- Collaborate with financial institutions to establish and deliver financial training programs for cooperatives and small enterprises.

- Create financial mechanisms and business models to facilitate access to loans and investments for transport modernization.
- Assist with the reform of environmental regulations to modernize old vehicles and promote cleaner transport alternatives.
- Design and implement comprehensive Monitoring, Reporting, and Verification (MRV) systems for tracking transport-related data, including emissions and fleet composition.
- Develop and update emissions inventories for the transport sector
- Support the project's transport and interface components, ensuring methodologies employed are culturally sensitive and gender responsive.

## Partnership and Stakeholder Engagement:

- Design and implement train-the-trainer programs focusing on gender inclusivity to empower women in the transport sector.
- Initiate and sustain dialogues with governmental and non-governmental entities to foster collaborative outcomes across all TRANSCEND project outputs.
- Cultivate and oversee partnerships with relevant government agencies, civil society organizations, and international climate bodies, aimed at achieving TRANSCEND's targeted objectives.
- Interface with local governments and communities for the effective rollout of project initiatives in all three landscapes where applicable.

# Additional Responsibilities:

- Ensure that TRANSCEND activities in the transport and interface components are following IKI and TRANSCEND guidelines, and prepare periodic reports summarizing project progress and milestones.
- Contribute to organizational priorities beyond the project's scope and engage in special initiatives as required.

- In-depth knowledge of international climate frameworks like the UNFCCC and the Paris Agreement, and proven ability in conducting policy assessments, making actionable recommendations, and advising on local to international level climate issues.



- A track record of working with transport models and planning to inform policy decisions, and of contributing to international discussions on energy policy.
- Exceptional stakeholder management skills, with robust experience in partnership building across government agencies, civil society organizations, and international bodies, and in managing complex multi-stakeholder implementation processes.
- Outstanding communication abilities, proficient in both English and Filipino, complemented by experience in strategic development, long-term planning, and the facilitation and organization of high-level national and international events.
- Results-oriented in performing tasks and having attention to details, from demand-based planning through implementation, innovation & learning, and knowledge management
- Experienced with procedures of German or other commissioning parties.
