The challenge

This diversity is the added value of multi-stakeholder partnerships, but it also makes for a challenging collaboration. Experience shows, however, that even very divergent stakeholders can agree on and achieve a common objective if they are convinced that their joint effort is worthwhile and that the partnership can succeed.

Involving stakeholders

An example from the field

Products containing cocoa are very popular with consumers, but the living and working conditions of cocoa farmers in the growing regions are often difficult and production frequently involves environmentally harmful practices. In Germany, one of the world's biggest export markets for cocoa, several institutions and businesses have already taken the first steps to establish sustainable cocoa production. However, this is not achievable unless all stakeholders cooperate. That is why the German Initiative on Sustainable Cocoa was established. It is a multi-stakeholder partnership that combines private sector enterprises, the German Federal Government (represented by the German Federal Ministry for Economic Cooperation and Development and the German Federal Ministry of Food and Agriculture), the food retail

industry, NGOs and standard setting organisations. Its aim is to improve the living conditions of the cocoa farmers and their families, to conserve natural resources and biodiversity in producer countries, and to increase the cultivation and marketing of sustainable cocoa. Close cooperation with producer countries is crucial for the success of this multi-stakeholder partnership.

The GIZ provides the secretariat for the German Initiative on Sustainable Cocoa and arranges stakeholder cooperation. This allows the partners to develop solutions together in order to promote more sustainable cocoa production:

- » The partnership developed best-practice criteria to create a basis for cooperation in sustainable cocoa cultivation.
- » Together with the Ivorian and German government, the partnership initiated a project to professionalize cocoa cultivation. Its aim is to increase family incomes and improve living and working conditions in the growing areas.
- » The partnership supports a supra-regional capacity building initiative that aims to train cocoa farmers in Côte d'Ivoire, Ghana and Nigeria in sustainable growing methods and good farm management, and prepare them for possible certification.

More than 70 members now contribute to the objectives of the Initiative. The partnership has already achieved one of its main goals four years ahead of schedule: the share of sustainably produced cocoa in confectionery sold in Germany has grown to more than half.
