GIZ in Ukraine

Fostering private-sector engagement, developing partnerships together



Ukraine needs strong economic partners and investment to rebuild the country and create jobs. The country is a promising sales market for German and European businesses – Ukraine does, after all, have EU candidate status. This means that it is implementing reforms to create a business environment that attracts investors, for instance by eliminating barriers to trade and simplifying administrative processes. Numerous initiatives by the German Government and the EU – ranging from investment and export credit guarantees to specific financing and procurement programmes – also offer German and European companies a wide range of opportunities to use their technologies to help shape the reconstruction of Ukraine.

The German private sector is already showing a marked interest in driving trade between the two countries and getting involved in reconstruction. New market opportunities are opening up for both sides, and knowledge transfer in both directions is gaining traction. In the IT sector, for instance, German and European companies can learn a great deal from the innovative force of their Ukrainian neighbours and, through close cooperation, establish contacts with potential business partners. Economic engagement is also creating jobs in Ukraine and offering prospects for Ukrainians who have fled, encouraging them to return home.
