At the start of Russia's full-scale war of aggression, the Ukrainian economy was severely impacted. Sales markets collapsed and foreign investment dried up. Some companies close to the front had to relocate their activities. There is still a widespread lack of skilled labour, as many people have left the country or are fighting at the front. Thanks to its quick change of direction and innovative strength, Ukraine has managed to stabilise its economy, forge international partnerships and push ahead with the reforms necessary to connect to the EU Single Market – all in the middle of the war. But Ukraine still needs strong partners at its side. The Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH is supporting Ukraine on behalf of the German Government, the EU and other donors as it moves to become a competitive and reliable partner in the EU, offering attractive openings for German and European investors.

✓ Fostering competition and innovation

- We strengthen businesses by fostering innovation, developing digital processes and providing access to support services such as regional support and investment schemes.
- We help companies develop international business relations and adapt to EU market requirements, including certification.
- We support businesses with strategic export promotion and help them establish a foothold in new markets, for example by attending trade fairs, undertaking delegation trips and making use of one-on-one advisory services.

✓ Training specialists for reconstruction

- We train internally displaced persons, veterans, returnees and vulnerable groups and help them (re)integrate into the labour market.
- We develop tailored training programmes geared to the needs of the European labour market.

✓ Adapting government frameworks for economic transformation

- We support state institutions in improving the framework conditions for investment and business growth.
- We support the reform and modernisation of state institutions to foster transparency, efficiency and accountability, laying stable foundations for sustainable economic growth.

✓ Moving closer to the EU Single Market by introducing common standards

- We help Ukraine adapt to EU regulations and standards.
- We build international networks and sectoral partnerships.
- We work with Ukrainian ministries, supervisory authorities and businesses to undertake specific reforms for integration into the EU Single Market.
