

TERMS OF REFERENCE

EU-PH Green Economy Partnership

Internship Opportunity

1 Background

Funded by a P3.67 billion (€60 million) grant from the European Union (EU), the EU-PH Green Economy Partnership is part of EU's Global Gateway initiative – the European strategy engaging with partners globally and promoting investments around shared priorities such as the transition to a green economy. Led by the Department of Environment and Natural Resources (DENR), this priority programme of the EU in the Philippines links European and Filipino partners from the private sector and the local government to foster a circular economy while sustaining economic growth that benefits all Filipinos.

The Policy and Alliances component of the programme – co-funded with a €12 million grant from the European Union and a €1 million contribution from the International Climate Initiative of the German Federal Ministry for the Environment, Climate Action, Nature Conservation, and Nuclear Safety and implemented by GIZ and DENR-Environmental Management Bureau – supports policy development and fosters strong partnerships. The component also aims to measure climate benefits, particularly reducing greenhouse gas (GHG) emissions, and is supported with the regional IKI project Urban-Act.

2. Tasks

The Project is looking for a Graphics and Multimedia Design Intern to perform the following tasks:

- Design visual outreach materials such as social media graphics, infographics, posters, banners, roll-ups, event backdrops, digital flyers, and publication covering programme activities and outreach materials.
- Assist in designing and formatting information, education, and communication assets/collaterals such as presentations, factsheets, briefs, reports, and training materials.
- Help prepare visual storyboards, shot lists, and scripts for video and multimedia content.
- Support the production of short-form videos such as event highlights, interviews, testimonials, reels, motion graphics, and animated explainers aligned with the programme's outreach initiatives.
- Support documentation of workshops, meetings, and events through photo documentation, graphic summaries, visual highlights, and post-event communication materials.

- Ensure that all visual outputs are consistent with the programme's branding guidelines.

3. Duration and Reporting

The engagement will be for a five-month duration. The start date can be flexible, depending on the intern's availability.

The intern shall be assigned to the GIZ Office, 3F SECAL Building DENR Central Office Compound, Visayas Ave., Diliman, Quezon City.

Occasional domestic travel may be required to partner cities.

4. Requirements

The qualifications for this role are the following:

- Currently pursuing a degree in:
 - Multimedia Arts
 - Graphic Design
 - Fine Arts
 - Visual Arts/Communication
 - Digital Media
- Basic to intermediate proficiency in design and multimedia tools and/or other relevant design and video-editing software, i.e. Canva.
- University endorsement (from a professor or department) is required.
- Submission of a portfolio or sample of works (academic, personal, or internship-related) is preferred.
- Familiarity with any of the key topics related to the Project (e.g., green and circular economy, climate change, or waste management) is a plus.
