Additionally, If your bid file is greater than 10MB, we recommend that you split the Offers into several emails (<10MB).

Please submit your bid in **two separate** PDF files:

1. **One file** for the administrative documents for Companies
2. **One file** for the financial offer (Companies and Individuals)
3. **One document** for the technical offer (It should contain the specifications and images of all the materials) (Companies and Individuals)

Bids not delivered on the email address, time and date as specified will not be evaluated. All bids must be signed and stamped.

Terms of delivery and place of delivery:

Quantity required: 100 metric tons (100,000 kg)

All maize supplied shall comply with the technical specifications outlined below and be suitable for poultry feed manufacturing.

The maize must be:

- Yellow maize grain intended for animal feed production;
- Clean and free from contamination;
- Free from mold, pests, insects, foreign materials and objectionable odors;
- Suitable for grinding and inclusion in poultry feed formulations.
- The maize must be available immediately.
- All consignments will be subject to sampling and quality verification prior to acceptance.
- Delivery, sampling and quality verification will be done at **SBD Lion Poultry** in Makeni.

Delivery and logistics

The contractor shall:

- Transport and deliver all supplies to designated delivery location in Makeni;
- Ensure safe handling and transport of equipment and materials;
- Coordinate deliveries with GIZ and relevant SBD Lion Poultry Staff
- Provide delivery notes and inventory documentation.

Delivery locations include:

- Makeni

Upon delivery, the maize will be inspected, any maize that fails to meet the agreed standard will be rejected and asked for replacement. Cost of delivery should be stated separately in the offer.

Delivery time:

The delivery time of the goods after ordering must be stated in the quotation. All ordered goods must be delivered at the latest date stated in the bid. Later deliveries cannot be accepted within this tender. In the event of late delivery goods may not be accepted by GIZ.

Prices:

Prices shall be listed, excluding VAT/GST and other public charges separately in your offer. The prices shall include the costs for goods, packing, marking, export fees and insurance and all other local costs incidental to deliver the goods to the final destinations.

Warranty:

Warranty/shelf-life period must be stated for the Maize in your quotation document presented.

Bid Currency, Validity and Language:

Prices shall be quoted in **New Leones (SLE)**.

Bids showing other currencies will not be considered.

Bids shall remain valid for 30 days after the deadline for submission of bids.

A bid valid for a shorter period will be rejected by the GIZ as non-responsive.

The language of the bid shall be English.

Payment Terms:

Full payment will be made within 10 days after completion of delivery, subject to appropriate deduction for incomplete and delayed deliveries, upon presentation of

- A commercial invoice (specifying quantities, units, total prices etc.). Supplier is responsible for submitting the invoice in New Leones (SLE)

- Should there be payment by transfer, the supplier will be required to supply full banking details to the GIZ Office.

Tender Results:

If you do not receive an order/notice in writing within 30 days after the submission deadline, your bid has not been considered. You shall not receive separate notice to this effect. The results will not be made public.

Question:

*Any formal, technical, financial, or logistical question related to this tender can be asked until **07.08.2026**. All your questions will be neutralized, and the answers will be shared with all Suppliers that has collected bidding documents. Delayed questions cannot be considered and accepted by us.
