Integrated Peatland Protection and Management Project (ProMangrovePeat) is a bilateral collaborative project between the Government of Indonesia and the German Federal Government through the German Federal Ministry for Economic Cooperation and Development (BMZ). It is implemented by the Directorate of Peat Degradation Control under the Ministry of Environment and the German Agency for International Cooperation (GIZ). It builds upon the achievements of the first phase of PROPEAT. During Phase 1, the primary objective was the development of an integrated management plan of the Peatland ecosystem supported by a detailed PHU map. There were 7 RPPEG documents acknowledged by the local government – 2 documents of provincial level and 5 of district level.

The project is now seeking a company/consulting firm to develop a series of educational and awareness-raising videos focusing on peatland and mangrove ecosystem management and protection in East Kalimantan or North Kalimantan. The videos are expected to reflect real field experiences, local knowledge, community practices, and key environmental messages aligned with the programme objectives.

Tender requirements:

Bids are to be submitted using the two-file procedure.

Bids must be sent in separate PDF files (duly identified as technical proposal and financial proposal). Price information shall not appear in any part of the technical proposal. Financial proposal (should be password-protected). We will request the password if your proposal is deemed technically compliant. Bidders are not allowed to change the password after the deadline of submission.

The default size of e-mails is limited to 10 MB. Above that, GIZ's email servers refuse the message and its attachments. If necessary, send more than one e-mail.

1. Content of the Technical and Financial Proposal

The technical proposal should consist of:

- Technical-methodological concept; how the objectives defined in TOR are to be achieved (see Chapter 3 in TOR)
- CV of assigned experts, including position in the team (see Chapter 4 in TOR)
- Company profile including relevant experiences
- Self-declaration of eligibility (Annex 4)
- Formal Declaration of GIZ GTC Acceptance (Annex 8)
- Declaration of Acceptance VAT (Annex 9)
- Company Data Sheet (Annex 10)
- Legal documents: copy of business license, Taxpayer Registration Number (NPWP), including PKP/Non-PKP letter

Financial Proposal should consist of:

- Financial offer shall refer to the detailed costs in Price Schedule (Annex 5) must be signed and stamped as approved by the bidder
- Bank account information
- All prices must be inclusive of income tax (PPH 23), as GIZ is obliged to withhold the income tax
- All prices must be exclusive of Value Added Tax (VAT). Please provide a taxable or non-taxable letter (PKP or Non-PKP)
- The currency of the financial proposal shall be in IDR

2. Value Added Tax

All prices/rates quoted must be exclusive of all taxes, since GIZ, including its subsidiary organs, is exempt from taxes.

According to the PMK No. 215/PMK 03/2008 and KMK No. 17/KMK 010/Year 2021. The Value Added Tax shall be exempted by BADORA (code 080). The process of tax exemption shall take around 2 – 3 months.

3. Technical and Financial Assessment or Evaluation

We will evaluate the bids received in the light of both technical and price considerations. The technical proposal will be evaluated based on the criteria and weighting (Annex 2 Technical Assessment Grid).

All financial factors will be analysed and compared to ensure that the price of each item is reasonable and comparable. A financial proposal may be corrected in the following cases: inconsistencies/discrepancies, calculation errors, and unjustified additions or omissions. GIZ will inform each bidder of the changes and ask them to either accept the corrections or reject them. All corrected financial proposals rejected by the bidders will be rejected. Only the financial proposals that satisfy all the requirements at the preliminary examination stage will be qualified for the detailed financial evaluation stage.

When the technical evaluation has been completed, the financial proposal of those bidders who are eligible from the technical point of view will be opened and evaluated by the commercial officer responsible. The technical and financial proposals are weighted at a ratio of 70:30, respectively. The technical bid will be weighted with 70% and the financial proposal with 30% based on the following formula: (Technical points obtained by Bidders X divided by the best number of points) x 70 % + 30 % x (Lowest price divided by the price of Bidders X).

$$\frac{\text{Technical evaluation of bid} \times 70\% + \text{most economical bid} \times 30\%}{\text{Technical evaluation of the best bid} \quad \text{price of the bid}}$$

An overall order of rank is thus established, with the most cost-effective bid at the top.

If necessary, GIZ has the right to invite bidders for a presentation proposal as it is part of the technical evaluation process.

4. Validity of Proposals

Proposals should be valid for a period of not less than 100 days after proposal opening, unless otherwise specified in the specific terms and conditions. Bidders are requested to indicate the validity period of their proposal.

5. Modification/withdrawal of the bid

Adjustment to or withdrawal of bids is to be communicated in writing by post by the deadline for submission of bids. Subsequent adjustments or modifications to the bid, which can be submitted up to the deadline for submission of bids, shall also be subject to the requirements for sending in the bid.

7. Contract Award / Adjudication of Proposals

The contract will be awarded to the bidder who offers the most responsive evaluated proposal and whose services are both commercially and technically acceptable (best overall value). If necessary, GIZ will negotiate only with the highest-ranking bidder.
